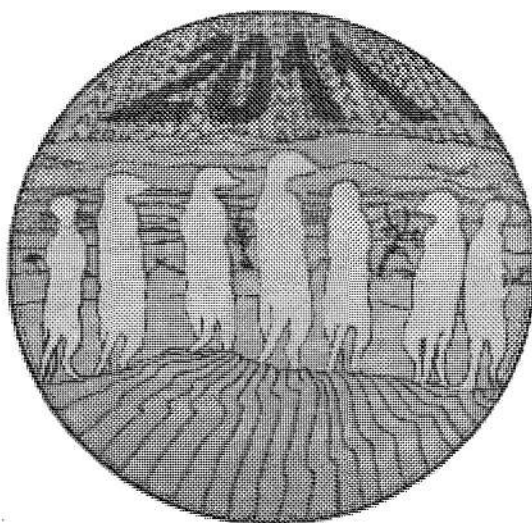

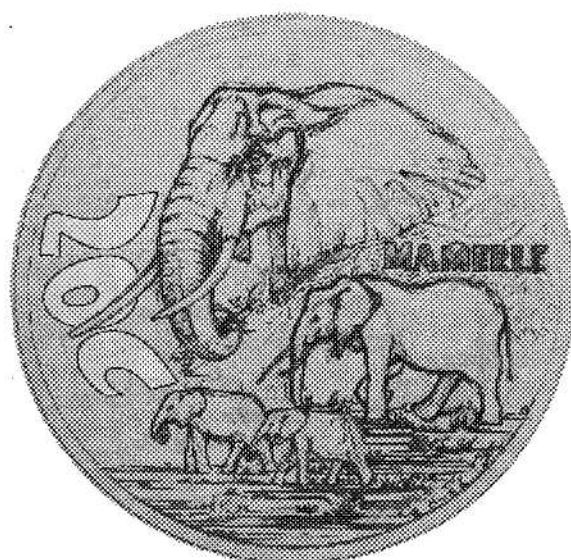

**Great Limpopo Transfrontier Park**



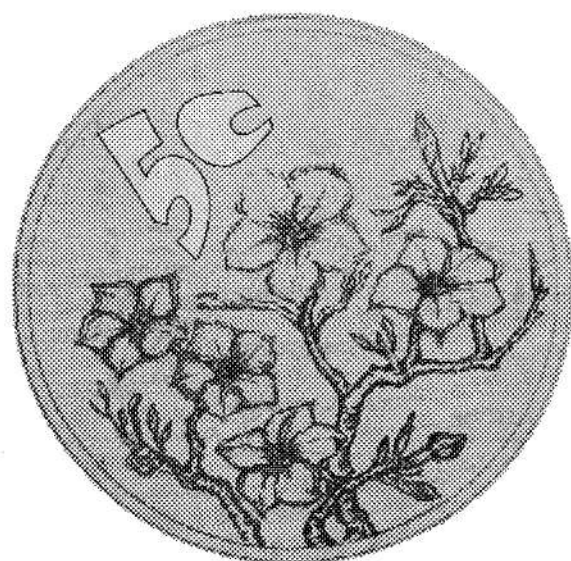
Reverse - 50c (2oz) Silver Coin
