1. I, Angelina Matsie Motshekga, Minister of Basic Education, after consultation with the Council of Education Ministers and in terms of Sections 3(4)(l) and 7 of the National Education Policy Act, 1996 (Act No. 27 of 1996) and together with section 6(A) of the South African Schools Act, 1996 (Act. No. 84 of 1996), hereby give my intention to amend policy and accordingly invite stakeholder bodies and members of the public to comment on the draft policy document, National Policy Pertaining to the Programme and Promotion Requirements of the National Curriculum Statement Grades R - 12.

# BACKGROUND

- 2. The National Curriculum Statement Grades R 12 represents a policy statement for learning and teaching in schools located in both the General Education and Training (GET) and Further Education and Training (FET) Bands and comprises the:
  - (a) National Curriculum and Assessment Policy Statements for all approved subjects for Grades R - 12; and
  - (b) The Policy document, National policy pertaining to the programme and promotion requirements of the National Curriculum Statement Grades R - 12.
