- (i) Internal Moderators are expected to review the question papers and ensure that the standard and quality of the paper is in keeping with the requirements of the Subject Statements and the Subject Assessment Guidelines.
- (ii) He/she takes responsibility for the accuracy of the content and ensures compliance with the principles of good assessment.
- (iii) He/she assumes final responsibility and accountability for the question paper prior to submission to the Umalusi moderator.
- (iv) The level of expertise demonstrated by the internal moderator should therefore be higher than that of the Chief Examiner.
- (v) The Internal Moderator is also expected to moderate a sample of the marked examination scripts.
