Stakeholder bodies and members of the public were invited to comment on the other two components of the *National Curriculum Statement Grades R – 12*, namely the curriculum and assessment policy statements, and the policy document, *National policy pertaining to the programme and promotion requirements of the National Curriculum Statement Grades R – 12* in *Government Gazette No. 33528* of 3 September 2010 and *No. 33952* of 24 January 2011 respectively.
