PROCLAMATION*by the**President of the Republic of South Africa***No. 69, 2011****DETERMINATION OF SALARIES AND ALLOWANCES OF THE TRADITIONAL LEADERS, MEMBERS OF THE NATIONAL HOUSE AND PROVINCIAL HOUSES OF TRADITIONAL LEADERS**

1.
