#### MARKETING OF AGRICULTURAL PRODUCTS ACT, 1996 (ACT No 47 OF 1996)

#### ESTABLISHMENT OF STATUTORY MEASURE: RECORDS AND RETURNS RELATING TO OLIVE TREES AS WELL AS DOMESTIC PRODUCTION AND PROCESSING OF TABLE OLIVES AND OLIVE OIL, AND IMPORTATION OF TABLE OLIVES AND OLIVE OIL

I, Tina Joemat-Pettersson, Minister for Agriculture, Forestry and Fisheries acting under sections 13 and 18 of the Marketing of Agricultural Products Act, 1996 (Act No 47 of 1996), hereby establish the statutory measure set out in the Schedule.

## SCHEDULE

### Definitions

1. In this Schedule any word or expression to which a meaning has been assigned in the Act shall have that meaning, and unless the context indicates otherwise :

**"Extra virgin olive oil"** means olive oil which conforms to all the conditions set out by the International Olive Council (IOC) for extra virgin olive oil;

**"exporter"** means an entity which exports processed and or unprocessed fruits and or products of the Olea europaea;

**"fresh olives"** means the unprocessed fruits of the Olea europaea to be used for the production of table olives, olive paste or olive oil;

**"grower"** means any entity involved in growing the Olea europaea to be sold for commercial gain, i.e. nurseries;

**"importer"** means an entity which imports packaged product ready for retail distribution;

**"olive industry"** means all participants and role players in the South African olive industry;

**"olive oil packer"** means the entity which buys in olive oil in bulk and packages the oil for resale;

**"olive pomace oil"**

**"olive oil processor"** means the entity which extracts olive oil from fresh olives;

**“olive products”** means the processed products obtained from fresh olives, namely table olives, extra virgin olive oil and virgin olive oil;

**“olives”** means the fruits of the Olea europaea;

**“processed olive products”** means the fruits which have been processed and are ready for consumption;

**“processed table olives”** means olives that have been processed and are ready for consumption;

**“fresh olives”** means the unprocessed fruits of the Olea europaea to be used for the production of table olives, olive paste or olive oil;

**“grower”** means any entity involved in growing the Olea europaea to be sold for commercial gain, i.e. nurseries;

**“olive oil processor”** means the entity which extracts olive oil from fresh olives;

**“olive products”** means the processed products obtained from fresh olives, namely table olives, extra virgin olive oil and virgin olive oil;

**“olive trees”** means Olea europaea trees of any cultivar;

**“olives”** means the fruits of the Olea europaea;

**“processed olive products”** means the fruits which have been processed and are ready for consumption;

**“processed table olives”** means olives that have been processed and are ready for consumption;

**“producer”** means the entity which grows olive trees to produce fresh olives for commercial gain;

**“table olive packer”** means the entity which buys in processed table olives in bulk and packages these olives for resale;

**“table olive processor”** means the entity which converts the fresh olives into product which can be consumed;

**“The Act”** means the Marketing of Agricultural Products Act, 1996 (Act No 47 of 1996);

**“virgin olive oil”** means olive oil which conforms to all the conditions set out by the International Olive Council (IOC) for extra virgin olive oil.

A person shall have a choice to register as either a producer or as an importer or as a processor. A person who is a producer as well as an importer and/or processor, must register as a producer and as an importer and/or processor.

#### **Purpose and aims of statutory measure and the relation thereof to the objectives of the Act**

2. The levy is needed by SA Olives to fund research projects, technical information and technology transfer; quality control and certification; information and statistics; communication, consumer education and market development; and transformation and training for the olive industry.

These measures are necessary to ensure that continuous, timeous and accurate information relating to the olive industry, is available to all role players in order for them to make informed decisions.

The measure will not be detrimental to the number of employment opportunities or fair labour practice and will support the statutory

measures relating to registration and the rendering of returns applicable to olive products.

The measure will be administered by HORTGRO<sup>SERVICES</sup>, a company incorporated under section 21 of the Companies Act, 1973 (Act 61 of 1973). HORTGRO<sup>SERVICES</sup> will implement and administer the measure as set out in the Schedule on behalf of DFPT Finance, a company incorporated under section 21 of the Companies Act, 1973 (Act 61 of 1973).

**Products to which statutory measure applies.**

3. This statutory measure shall apply to table olives and olive oil both from domestic production and imports.

**Area in which measure shall apply**

4. This measure shall apply in the geographical area of the Republic of South Africa.

**Imposition of levy**

5. A levy is hereby imposed on table olives and olive oil.

**Amount of levy**

6. The amount of the levy shall be:

- (a) 8c/kg on all table olives; and
- (b) 40c/litre on all olive oil.

**Persons by whom and to whom levy shall be payable**

7. (1) The levy imposed under clause 5 shall –

- (a) be payable by a table olive and/or olive oil producer and/or processor and/or importer.
- (2) A levy imposed under clause 5 shall be payable to DFPT Finance in accordance with clause 8.

### **Payment of levy**

8. (1) Payment of the levy shall be made not later than thirty (30) days following the month end wherein a quantity of table olives and/or olive oil was delivered or imported for sale on the domestic market.
- (2) Payment shall be made by means of a cheque or electronic transfer in favour of DFPT Finance, and shall –

## SCHEDULE

Definitions

1. In this Schedule any word or expression to which a meaning has been assigned in the Act shall have that meaning unless the context otherwise indicates –

**“cotton”** means cotton lint and seed cotton derived from the ball of the cotton plant (*Gossypium hirsutum*);

**“cotton lint”** means the fibre derived from the seed cotton after the seed cotton has been ginned;

**“Cotton South Africa”** means the Company registered in terms of section 21 of the Companies Act, 1973 (Act No. 61 of 1973), which operates under the name Cotton South Africa;

**“ginner”** means any person who gins seed cotton;

**“gin”** in relation to seed cotton, means to separate the seed and fibre in seed cotton and ginning has a corresponding meaning;

**“seed cotton”** means the lint and seed derived from the ball of the cotton plant (*Gossypium hirsutum*), before it has been ginned; and

**“the Act”** means the Marketing of Agricultural Products Act, 1996 (Act No. 47 of 1996).

Purpose and aims of the statutory measure and the relation thereof to objectives of the Act

2. The purpose and aims of this statutory measure are to provide financial support for the following functions that the cotton industry has identified as essential and in the interest of the industry as a whole:

- (a) Rendering of information services to all role players;
- (b) the promotion of cotton production and the demand;
- (c) the co-ordination of research;
- (d) the maintenance of quality standards and norms and the provision of training; and
- (e) the facilitation of the development of the emerging cotton production sector.

The maintenance of macro industry information is regarded as critical for strategic planning by the cotton industry. Proper and accurate market information that is available on a continuous and timeous manner, will not only increase market access for all market participants, but will also promote the efficiency of the marketing of cotton.

The promotion of the production of cotton can make a significant contribution towards the level of household food security in South Africa, particularly in the more arid regions of the country where other summer crops have regularly failed. It is furthermore important that perceptions be changed in terms of crops more suited to those areas to feature more strongly.

Research is essential for the furtherance of the primary cotton industry's competitive position, taking into account the extremely competitive marketing environment in which cotton compete and the steady decline in the cotton fibre market over the past few years. Research is also important for cotton cultivation by commercial and small-scale farmers. Studies in connection with cultivar characteristics such as yield tendencies, adaptability and yield stability, make it possible for the cotton producer to make meaningful cultivar choices for specific conditions.

Quality standards, grading and classification as well as independent arbitration services for quality disputes have to be maintained in order to promote the efficiency of cotton marketing *per se*. This function is deemed a basic precondition for the orderly marketing of cotton. Therefore, grading staff at co-operatives and processors of cotton also have to be trained on a continuous basis.

A portion of the funds collected by means of this levy will also be focused on small-scale farmers and the developing cotton industry.

The established of this statutory measure will not only assist in enhancing market access for all market participants but will also enhance the viability of the cotton industry. The establishment of this measure will in fact further all the objectives of the Act as stipulated in Section 2 thereof.

This statutory measure shall be administered by Cotton South Africa.

Product to which statutory measure applies

3. This statutory measure shall apply to cotton lint.

Area in which statutory measure applies

4. This statutory measure shall apply within the geographical area of the Republic of South Africa.

Imposition of levy

5. A levy is hereby imposed on all cotton lint, ginned by ginners from seed cotton.

Amount of levy

6. The levy shall be as follows (VAT excluded):

- From 1 April 2012 to 31 March 2013: 20c/kg on cotton lint, and
- From 1 April 2013 to 31 March 2014: 21c/kg on cotton lint.

Persons by whom and to whom levy is payable

7. The levy imposed in terms of clause 5 and 6 shall –

- (a) be payable by ginners; and
- (b) be payable to Cotton South Africa.

Payment of levy

8.(1) Payment shall be made not later than the 20<sup>th</sup> day that follows the month during which the cotton lint on which the levy is payable, was produced.

(2) Payment shall be made by means of a cheque, postal order or money order made out in favour of Cotton South Africa.

Conditions of approval

9. This statutory measure is subject to the following conditions:

- a) that 70% of levy income is spent on core activities (such as research and information functions), 10% on administration and approximately 20% on transformation (development of emerging farmers);
- b) that annual audited financial statements be submitted to the NAMC and the Auditor-General, with the percentage allocated towards transformation clearly indicated and accompanied by a report stating how the objectives of the levy have been met;
- c) that surplus funds should not form part of the assets of the body administrating the levy and would be utilised with the discretion of the Minister after the lapsing of the levy (after 4 years);

- d) that levies must be accounted for, in a manner and to the extent acceptable to the Auditor-General, separately from any other funds or assets under the control of the levy administrator; and
- e) that electronic data regarding the implemented statutory measures on the whole industry be supplied to the NAMC on a quarterly basis.

**Commencement and period of validity**

**NOTICE OF DECLARATION OF PARTICULAR TREES AND PARTICULAR GROUPS OF TREES "CHAMPION TREES" UNDER SECTION 12(1) (A) AND (B) OF THE NATIONAL FORESTS ACT, 1998 (ACT NO. 84 OF 1998), AS AMENDED.**

By virtue of powers vested in me under Section 12 (1) (a) and (b) of the National Forests Act, 1998, I, Tina Joemat-Pettersson, Minister of Agriculture, Forestry and Fisheries hereby declare that all particular trees and particular group of trees set out in the schedule below as protected trees. These trees are added to the existing list of declared Champion Trees.

The effect of this declaration is that in terms of Section 15 (1) of the National Forests Act, 1998, no person may cut, disturb, damage or destroy any protected tree or possess, collect, remove, transport, export, purchase, sell, donate or in any other manner acquired or dispose of any protected tree or any forest product derived from a protected tree, except under a licence granted by the Minister or in terms of an exemption from the provisions of this subsection published by the Minister in the Gazette on the advice of the Council.

Contravention of this declaration is regarded as a first category offence that may result in a person who is found guilty of being sentenced to a fine or imprisonment for a period up to three years, or both a fine and imprisonment.

**SCHEDULE A**
