  - Applications FOR RENEWAL OF radio frequency spectrum licences as stipulated under Part IV Sections 9 (1) to (4) of the Radio Frequency Spectrum Regulation notice no 34172 issued on 31 March 2011.
  - Applications for A MULTIPLE YEAR LICENCE for Amateur, Aeronautical and Ship station categories stipulated under Section 8 (1) to (2) of the Radio Frequency Spectrum Fee Regulations, notice no 33495 issued on 27 August 2010.

### Draft Radio Frequency Spectrum Regulation

- Licensees under the categories mentioned in paragraph 1 above are encouraged to apply for a five year licence to qualify for the discount in radio frequency spectrum fees payable.
- 4. Licences for which no renewals are submitted will be regarded as **EXPIRED AND INVALID** at the end of the current financial year.
- 5.
