EXEMPTION PERMIT FEES

It is one of the basic functions of the Abnormal Loads Technical Committee to recommend the fees relating to exemption permits. For obvious considerations of credibility and efficiency fees should be uniformed calculated and applied by all provinces. The new fees will be effective from 1 April 2013.

The fees are set to optimise the income derived by the provincial governments based on actual scientifically determined costs and indexed to the Producer Price Index (PPI)
