This Gazette is published in terms Section 25(6)(b) of the Division of Revenue Act, 2012 (Act No. 5 of 2012), therefore schedule 8 makes special provisions for the immediate release of funds to provinces and municipalities following declared disasters.

A portion of an unallocated amount of Municipal Disaster Grant was transferred to two municipalities in the Western Cape during July and August 2012 following the damage caused by heavy rains.
