

NOMINATIONS OF CANDIDATES TO SERVE AS PART-TIME REGULATOR MEMBERS FOR THE NATIONAL ENERGY REGULATOR OF SOUTH AFRICA (NERSA)

The National Energy Regulator of South Africa (“**NERSA**”) is a regulatory authority established as a juristic person in terms of section 3 of the National Energy Regulator Act 40 of 2004 (“**the NERA Act**”).

NERSA's mandate, in terms of section 4 of the NERSA Act, is to:-

- a) perform the functions of the Petroleum Pipelines Regulatory Authority, in accordance with section 4 of the Petroleum Pipelines Act, 60 of 2003;
- b) perform the functions of the National Electricity Regulator, in accordance with section 4 of the Electricity Regulation Act, 4 of 2006; and
- c) perform the functions of the Piped-Gas Regulator, in accordance with section 4 of the Gas Act, 48 of 2001.

In terms of section 5(1) of the NERA Act, NERSA consists of four Full-Time Regulator members and five Part-Time Regulator Members, all appointed by the Minister of Energy.

In terms of section 5(6)(a) and (b) of the NERA Act, a Part-Time Regulator Member holds office for a period of four years, while a Full-Time Regulator Member holds office for a period of five years.
