INTERIM RATIONALISATION OF JURISDICTION OF HIGH COURTS ACT, 2001 (ACT NO. 41 OF 2001)

ALTERATION OF THE AREA OF JURISDICTION OF THE NORTH WEST HIGH, MAHIKENG AND NORTHERN CAPE HIGH COURT, KIMBERLEY

I, Jeffrey Thamsanga Radebe, Minister of Justice and Constitutional Development, under section 2(1) of the Interim Rationalisation of Jurisdiction of High Courts Act, 2001 (Act No. 41 of 2001), hereby, after consultation with the Judicial Service Commission and after obtaining the approval of Parliament, with effect from 15 August 2013, alter the area of jurisdiction for which the Northern High Court, Mahikeng and the Northern Cape High Court, Kimberley were established as indicated in column A by including therein, as indicated in column B and excising therefrom as indicated in column C, the district as set out in the Schedule.
