A SHORTLIST OF SUITABLE PERSONS ELIGIBLE FOR APPOINTMENT AS DIRECTOR OF THE CIVIL AVIATION AUTHORITY

The Civil Aviation Authority is a national public entity established in terms of the South African Civil Aviation Act, 2009 (Act No. 13 of 2009). Its mandate is to control and regulate civil aviation safety and security; oversee the implementation and compliance with the National Aviation Security program; oversee the functioning and development of the civil aviation industry; promote civil aviation safety and security; develop regulations that are required in terms of the Act; and monitor and ensure compliance with the Act and the international Aviation Conventions.

The Civil Aviation Act makes provision for the Minister of Transport to appoint the Director to the Civil Aviation Authority. In appointing the Director of Civil Aviation Authority, the Minister is required, amongst others, to compile and publish a shortlist of suitable persons nominated or who have applied and who are eligible to be appointed as Director.

Therefore, this notice serves to publish a list of the following candidates -
