# **ELECTRONIC COMMUNICATIONS ACT, 2005 (ACT NO. 36 OF 2005)**

APPLICATION FOR TRANSFER OF LICENCE FROM ON DIGITAL MEDIA PROPRIETARY LIMITED ("ODM") TO STARTIMES MEDIA (SOUTH AFRICA) PROPRIETARY LIMITED

- 1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received an application from On Digital Media Proprietary Limited ("ODM") for a transfer of its Individual Electronic Communications Network Service (I-ECNS) Licence to StarTimes Media (South Africa) Proprietary Limited. This application is lodged in terms of regulation 11 of the Processes and Procedures Regulations for Individual Licences and Special Temporary Authorisations of 2010 read with sections 13(1) and (2) of the Electronic Communications Act, No. 36 of 2005.
- 2. The transfer application seeks the approval from the Authority to transfer the Individual Electronic Communications Network Service Licence from ODM to StarTimes Media (South Africa) Proprietary Limited.
- 3. The application, relevant schedule and any representations received pursuant thereto would be made available and open for inspection by interested parties in the Authority's library during the Authority's normal office hours.
- 4. Interested parties are invited to lodge written representations in relation to the application within fourteen (14) working days of the date of publication of this notice.

- 5. Persons who make such representations must indicate in their written representations whether they require an opportunity to make oral representations in the event the Authority decides to hold public hearings.
- 6. ODM shall be entitled to respond in writing to written representations made by interested persons on the transfer application, and such written response must be lodged with the Authority within twenty eight (28) working days of the date of publication of this notice in the *Government Gazette*. ODM must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, **OR** has sent a copy of such response by registered mail **OR** by facsimile **OR** by e-mail to the relevant person having made such written representations.
