### FINANCIAL MARKETS ACT, 2012

#### APPROVED AMENDMENTS TO DEPOSITORY RULES

- I Dube Phineas Tshidi, Registrar of Securities Services, hereby give notice under section 1(3)(c)(ii) of the Financial Markets Act, 2012 (Act No. 19 of 2012) that-
  - (1) the amendments proposed to the Rules of Strate Limited, a licensed central securities depository, published on the official website of the Financial Services Board (<a href="www.fsb.co.za">www.fsb.co.za</a>) (the FSB website) on 15 November 2013 and of which notice was given in Notice 225 of 2013, published in Government Gazette No. 37014 of 15 November 2013, have been approved;
