DETERMINATION OF SALARIES AND ALLOWANCES OF THE TRADITIONAL LEADERS, MEMBERS OF THE NATIONAL HOUSE AND PROVINCIAL HOUSES OF TRADITIONAL LEADERS

I hereby -

- (a) in terms of section 5(1) of the Remuneration of Public Office Bearers Act, 1998 (Act No. 20 of 1998) (hereinafter referred to as "the Act"), and after consultation with the Premiers concerned and after considering the matters listed in section 5(1) of the Act, determine, with effect from 1 April 2013, the salaries and allowances of the Traditional Leaders, Members of National and Provincial Houses of Traditional Leaders as set out in the attached Schedule, subject to the provisions of section 5(2), (4) and (5) of the Act and the terms and conditions set out in the Schedule; and
- (b) repeal Proclamation No. 9 of 2014, published in the Government *Gazette* No. 37352 of 18 February 2014.
