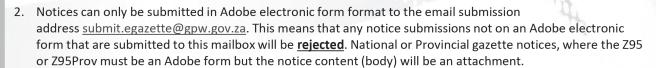

Government Printing Works has implemented rules for completing and submitting the electronic Adobe Forms when you, the customer, submits your notice request.

Please take note of these guidelines when completing your form.

#### **GPW Business Rules**

1. No hand written notices will be accepted for processing, this includes Adobe forms which have been completed by hand.



- 3. Notices brought into GPW by "walk-in" customers on electronic media can only be submitted in Adobe electronic form format. This means that any notice submissions not on an Adobe electronic form that are submitted by the customer on electronic media will be <u>rejected</u>. National or Provincial gazette notices, where the Z95 or Z95Prov must be an Adobe form but the notice content (body) will be an attachment.
- 4. All customers who walk in to GPW that wish to submit a notice that is not on an electronic Adobe form will be routed to the Contact Centre where the customer will be taken through the completion of the form by a GPW representative. Where a customer walks into GPW with a stack of hard copy notices delivered by a messenger on behalf of a newspaper the messenger must be referred back to the sender as the submission does not adhere to the submission rules.
- 5. All notice submissions that do not comply with point 2 will be charged full price for the notice submission.
- 6. The current cut-off of all Gazette's remains unchanged for all channels. (Refer to the GPW website for submission deadlines <a href="https://www.gpwonline.co.za">www.gpwonline.co.za</a>)
- 7. Incorrectly completed forms and notices submitted in the wrong format will be rejected to the customer to be corrected and resubmitted. NOTICE OF INTENTION TO EXTEND THE DUE DATE FOR THE SUBMISSION OF WRITTEN COMMENTS ON THE POSITION PAPER AND DRAFT REGULATIONS REGARDING THE REVIEW OF SOUTH AFRICAN LOCAL CONTENT ON TELEVISION AND RADIO

- (1) The Independent Communications Authority of South Africa ("the Authority") published, for comments, Position Paper and Draft Regulations on the review of South African Local Content on Television and Radio on the 18 June 2015 in General Notice 530, 531 and 532 of Government Gazette 38890.
- (2) In terms of the General Notice, interested parties were invited to make written comments by no later than 16h00 on the 14 August 2015.
- (3) Stakeholders requested an extension of the due date for submissions emphasising that they need extra time to fully consult and debate the issues with the industry. The discussions at the provincial workshops, they indicated, necessitate stakeholders to revisit their input. Furthermore they cited that the draft regulations contains technical and complex issues which must be properly understood and interpreted.

- (4) The Authority deems it advisable to extend the submission deadline to allow stakeholders to make sound and substantial input as this is the last round of submissions expected for the current review of South African Local Content.
- (5) The deadline for the submission of written comments on the above is extended to 31 August 2015.
