GOVERNMENT PRINTING WORKS - BUSINESS RULES

The **Government Printing Works (GPW)** has established rules for submitting notices in line with its electronic notice processing system, which requires the use of electronic *Adobe Forms*. Please ensure that you adhere to these guidelines when completing and submitting your notice submission.

CLOSING TIMES FOR ACCEPTANCE OF NOTICES

1. The *Government Gazette* and *Government Tender Bulletin* are weekly publications that are published on Fridays and the closing time for the acceptance of notices is strictly applied according to the scheduled time for each gazette.

GOVERNMENT PRINTING WORKS - BUSINESS RULES**NOTICE SUBMISSION PROCESS**

3. Download the latest *Adobe* form, for the relevant notice to be placed, from the **Government Printing Works** website www.gpwonline.co.za.
4. The *Adobe* form needs to be completed electronically using *Adobe Acrobat / Acrobat Reader*. Only electronically completed *Adobe* forms will be accepted. No printed, handwritten and/or scanned *Adobe* forms will be accepted.
5. The completed electronic *Adobe* form has to be submitted via email to submit.egazette@gpw.gov.za. The form needs to be submitted in its original electronic *Adobe* format to enable the system to extract the completed information from the form for placement in the publication.
6. Each notice submission should be sent as a single email. The email should contain **all documentation relating to a particular notice submission**, each as a separate attachment:
 - 6.1. Electronically completed *Adobe* form, specific to the type of notice that is to be placed.
 - 6.1.1. For *National Government Gazette* or *Provincial Gazette* notices, the notices must be accompanied by an electronic Z95 or Z95Prov *Adobe* form
 - 6.1.2. The notice content (body copy) **MUST** be a separate attachment.
 - 6.2. Proof of Payment / Purchase Order: **Government Printing Works** account customer must include a copy of their Purchase Order. **Non-Government Printing Works** account customer needs to submit the proof of payment for the notice
 - 6.3. Where separate notice content is applicable (Z95, Z95 Prov and TForm 3, it should also be attached as a separate attachment. (See specifications below, point 11).
 - 6.4. Any additional notice information if applicable.
7. The electronic *Adobe* form will be taken as the primary source for the notice information to be published. Instructions that are on the email body or covering letter that contradicts the notice form content will not be considered. The information submitted on the electronic *Adobe* form will be published as-is.
8. To avoid duplicated publication of the same notice and double billing, Please submit your notice **ONLY ONCE**.
9. Notices brought to **GPW** by "walk-in" customers on electronic media can only be submitted in *Adobe* electronic form format. All "walk-in" customers with notices that are not on electronic *Adobe* forms will be routed to the Contact Centre where they will be assisted to complete the forms in the required format.
10. Should a customer submit a bulk submission of hard copy notices delivered by a messenger on behalf of any organisation e.g. newspaper publisher, the messenger will be referred back to the sender as the submission does not adhere to the submission rules.

11. Where the copy is part of a separate attachment document for Z95, Z95Prov and TForm03
 - 11.1. Copy of notices must be supplied in a separate document and may not constitute part of any covering letter, purchase order, proof of payment or other attached documents.

The content document should contain only one notice. (You may include the different translations of the same notice in the same document).
 - 11.2. The notice should be set on an A4 page, with margins and fonts set as follows:

Page size = A4 Portrait with page margins: Top = 40mm, LH/RH = 16mm, Bottom = 40mm;
Use font size: Arial or Helvetica 10pt with 11pt line spacing;

Page size = A4 Landscape with page margins: Top = 16mm, LH/RH = 40mm, Bottom = 16mm;
Use font size: Arial or Helvetica 10pt with 11pt line spacing;

CANCELLATIONS

12. Cancellation of notice submissions are accepted by **GPW** according to the deadlines stated in the table above in point 2. Non-compliance to these deadlines will result in your request being failed. Please pay special attention to the different deadlines for each gazette. Please note that any notices cancelled after the cancellation deadline will be published and charged at full cost.
13. Requests for cancellation must be sent by the original sender of the notice and must accompanied by the relevant notice reference number (N-) in the email body.

AMENDMENTS TO NOTICES

14. With effect from 01 October 2015, **GPW** will not longer accept amendments to notices. The cancellation process will need to be followed according to the deadline and a new notice submitted thereafter for the next available publication date.

REJECTIONS

15. All notices not meeting the submission rules will be rejected to the customer to be corrected and resubmitted. Assistance will be available through the Contact Centre should help be required when completing the forms. (012-748 6200 or email info.egazette@gpw.gov.za). Reasons for rejections include the following:
 - 15.1. Incorrectly completed forms and notices submitted in the wrong format, will be rejected.

 - 15.3. Any notice submissions not accompanied by the proof of payment / purchase order will be rejected and the notice will not be processed.
 - 15.4. Any submissions or re-submissions that miss the submission cut-off times will be rejected to the customer. The Notice needs to be re-submitted with a new publication date.

16. Any notices other than legal notices are subject to the approval of the Government Printer, who may refuse acceptance or further publication of any notice.
17. No amendments will be accepted in respect to separate notice content that was sent with a Z95 or Z95Prov notice submissions. The copy of notice in layout format (previously known as proof-out) is only provided where requested, for Advertiser to see the notice in final Gazette layout. Should they find that the information submitted was incorrect, they should request for a notice cancellation and resubmit the corrected notice, subject to standard submission deadlines. The cancellation is also subject to the stages in the publishing process, i.e. If cancellation is received when production (printing process) has commenced, then the notice cannot be cancelled.

COMPETITION COMMISSION**NOTICE IN TERMS OF SECTION 10(7) OF THE COMPETITION ACT 89 OF 1998 (AS AMENDED): SOUTH AFRICAN PETROLEUM INDUSTRY ASSOCIATION GRANTED CONDITIONAL EXEMPTION**

On 22 December 2015, the South African Petroleum Industry Association ("SAPIA") and its members applied to the Competition Commission of South Africa ("Commission") in terms of Section 10(1)(b) of the Competition Act No 89 of 1998, as amended (the "Act") to be exempted from certain provisions of Section 4 of the Act. The exemption was sought for a period of five (5) years from 1 January 2016 ending on 31 December 2020.

Notice is hereby given in terms of Section 10(7) of the Act, that the Commission has extended the SAPIA exemption with 12 (twelve) months starting from 01 January 2017 ending 31 December 2017 on the same terms and conditions as published in Government Gazette No.34651 of 7 October 2011.

The exemption granted by the Commission covers a wide range of agreements and practices which, according to SAPIA, are required to ensure the continuity and stability of liquid fuels supply to various sectors and geographic locations of the South African economy. In particular, the exemption covers agreements and practices in the petroleum and refinery industry which are considered by the Commission to be in contravention of Sections 4(1)(a) and (b) of the Act.

The Commission has previously, in response to the above mentioned application, granted SAPIA a conditional exemption in terms of Section 10(2)(a) of the Act for a period of 6 (six) months starting from 01 January 2016 and ending on 30 June 2016. Following the expiry of the exemptions, the Commission further extended the conditional exemption until 31 December 2016. SAPIA based its application on the premise that the aforesaid agreements and practices are

required to obtain the objective set out under Section 10(3)(b)(iv) of the Act. This is after the Minister of Economic Development Department has designated the petroleum and refinery industry for a period of 6 (six) months starting from 01 January ending on 30 June 2016. Following, the expiry of the exemption and the industry designation, Economic Development Department granted SAPIA a further industry designation ending on 31 December 2016.

The Economic Development Department has recently granted SAPIA a further industry designation starting from 01 January 2017 ending 31 December 2017.

The Commission is satisfied that SAPIA's exemption will contribute towards maintaining the economic stability of the petroleum and refinery industry for the period starting on 01 January 2017 and ending on 31 December 2017.

SAPIA or any other person with substantial financial interest affected by this decision may appeal it to the Competition Tribunal in the prescribed manner in terms of Section 10(8) of the Act.

ANNEXURE

The exemption has been granted subject to the following conditions:

Preamble

The conditions below only apply for the purpose and duration of the exemption application. The exemption application relates to the cooperation agreements and/or practices between SAPIA and its members at the following stages of the liquid fuels supply chain: **Inbound logistics; primary distribution; terminal and depot operation and the specific shared services such as the airport fuelling services and the port joint bunkering services.** The exemption does not extend to the **wholesale, commercial and retail trade** of the supply chain.

1. *The exemption is granted on the basis of the facts and the existing agreements and practices described in the application. Should the facts and existing agreements and practices change materially, including any change caused by the proposed addition of a new participant to an exempt agreement or practice or the conclusion of a new agreement, the Commission should be notified of such change. Any new agreement which affects the agreements and practices described in the exemption application, or any amendment or addendum to agreements contained in the application shall not be of force or effect until approved by the Commission.*
2. *SAPIA and its members and any other approved participants in exemption agreements and practices may not share competitively sensitive information, except for the purposes described in the exemption application.*
3. *If:*
 - 3.1 *a party to an agreement or practice at any stage of the liquid fuels supply chain also acts as an operator of the infrastructure or coordinates the joint use of a facility to which that agreement or practice relates; and*
 - 3.2 *it is necessary for that operating party to be provided with disaggregated volume information of other participants, or any other information which may lead to a substantial lessening or prevention of competition;*

- 3.3 *then the operating party must not share that information with the other participants, unless sharing the information is necessary to ensure security, stability and continuity of liquid fuels supply, or is necessary for strictly operational purposes.*
- 3.4 *The employees of any operating party who receive such information shall ensure that the information is held, maintained and used separately, confidentially and on a need to know basis only.*
4. *SAPIA and its members may not share information relating to setting of margins, imposition of levies and / or approval of tariffs, unless required to do so by the Department of Energy or National Energy Regulator of South Africa.*
5. *SAPIA and its members and any other approved participants are required to comply in all material respects with all statutes, regulations and policies which have the force of law, and which directly relate to competition in the petroleum refining and marketing industry in South Africa. These industry regulations include but are not limited to: the Petroleum Products Amendment Act (58 of 2005), the Petroleum Pipelines Act (60 of 2003), the National Ports Act (12 of 2005), and Regulations in terms of the Petroleum Pipelines Act and the National Ports Regulations.*
6. *SAPIA must open up its membership to accommodate both existing and potential marketers in the petroleum and refinery market on fair, reasonable and transparent grounds.*

(hereinafter referred to as the "employees" or the "trade unions"), of the other part

being parties to the Furniture Bargaining Council,

hereby agree to amend the Main Collective Agreement published under Government Notice No. R.903 of 14 November 2014, as amended and extended by Government Notice No. R.37 of 22 January 2016, R.368 of 27 June 2016 and Government Notice No. 946 of 26 August 2016.

CHAPTER 1**CLAUSE 1: SCOPE OF APPLICATION**

Furniture manufacturing will also include the manufacturing, installation, repairing, polishing, re-polishing, staining, spraying of pianos, organs, movable room/office partitions, kitchen cupboards, kitchen cupboard tops, kitchen cupboard components (irrespective of materials used), attached wall cupboards, built-in cupboards, built-in cupboard components, free standing bars or built-in bar counters, cane, wicker or grass furniture, cabinets including cabinets for musical instruments and radios, wireless or television cabinets, bathroom cupboards, any other cupboard tops and furniture for tea-rooms, restaurants, offices, churches, schools, libraries, other educational institutions, conference centres and theatres but excluding the manufacturing of furniture made mainly of metal and/or plastic materials.

(2) **Bedding**

The manufacturing, repairing, covering, re-covering of mattress bases, mattresses, spring mattresses, overlays, bolsters, pillows, cushions for studio couches, spring units, box-spring mattresses and studio couches, but excluding the manufacturing of bedding made mainly of metal and/or plastic materials.

"Studio Couch" means an article of furniture, which is designed for seating and for conversion into a double bed or two or more beds and of which the frames are constructed mainly of metal and the seating and/or sleeping surfaces consist of mattresses and/or cushions.

(3) **Upholstery**

The upholstering or re-upholstering of any furniture, or item of furniture, bedding, pelmets and mattress bases."

4. NEWLY EMPLOYED EMPLOYEE CONCESSION

Substitute clause 8.3 with the following:





1.2.2 apply to learners under the Skills Development Act, 1998, or any contracts entered into or any conditions fixed thereunder.

2. PERIOD OF OPERATION OF AGREEMENT

This Agreement shall, in terms of section 31 of the Act, become binding on the above parties on 1 July 2016 and for non-parties on such date as determined by the Minister of Labour in terms of section 32 of the Act and shall remain in force for the period ending 30 June 2017.

3. TERMS AND CONDITIONS

A separate Collective Bargaining Fee Agreement is hereby agreed to and the provisions of the Labour Relations Act, 1995 (Act 66 of 1995)(as amended)(hereinafter referred to as the Act), where applicable, shall apply to this Agreement. The object of this Agreement is to ensure that all employees and employers in the scope of the Council who receive the benefits of collective bargaining contribute towards its costs.

5. COLLECTIVE BARGAINING FEE

- 5.1 A Collective Bargaining Fee is payable by an employer who is not a member of the representative employers' organisation known as the Furniture, Bedding & Upholstery Manufacturers' Association for the Greater Northern Region, although such an employer is eligible for membership thereof but is not compelled to be a member thereof.
- 5.2 For the purposes of this agreement, "representative employers' organisation" means a registered employers' organisation whose members employ the majority of employees in the furniture, bedding and upholstery manufacturing industry in the scope of the Council.
- 5.3 This Collective Bargaining Fee Agreement is binding on all employers who are not members of the representative employers' organisation, being the non-party employers in the furniture, bedding and upholstery manufacturing industry and in the scope of the Council's Main Agreement.
- 5.4 The prescribed Collective Bargaining Fee shall be equivalent to or less than the amount of the prevailing membership fees payable by the employer members of the Furniture, Bedding & Upholstery Manufacturers' Association for the Greater Northern Region to the same association.
- 5.5 The prescribed Collective Bargaining Fee payable by employers who are not members of the employers' organisation known as Furniture, Bedding & Upholstery Manufacturers' Association for the Greater Northern Region, who is a party to this Agreement, shall be as follows:

5.5.1 Monthly membership Fees (for all areas excluding the Free State Province)

- 5.6 Every non-party employer shall together with the Collective Bargaining Fee also submit to the Secretary of the Council, at the same time, a monthly return form reflecting the amount of the Collective Bargaining Fee due on the return form as specified by the Council from time to time.
- 5.7 The Secretary of the Council shall deposit all moneys received as Collective Bargaining Fees in terms of clause 5.5 into a bank account of the Council.
- 5.8 The prescribed Collective Bargaining Fee must be paid by the employers as identified in clause 5.3 to the Council by the 10th day of each month following the month in which it became due and the same Collective Bargaining Fee must be paid by the Council monthly to the Furniture, Bedding & Upholstery Manufacturers' Association for the Greater Northern Region.

- 5.9 The Secretary of the Council shall transfer all moneys received as Collective Bargaining Fees into a separate bank account administered by the party employers' organisation.
- 5.10 Despite sub-clause 5.9, a conscientious objector may request the Council in writing to pay his Collective Bargaining Fees into a fund administered by the Department of Labour.
- 5.11 No Collective Bargaining Fee may be:
- 5.11.1 paid to a political party as an affiliation fee; or
 - 5.11.2 contributed in cash or kind to a political party or a person standing for election to any political office; or
 - 5.11.3 used for any expenditure that does not advance or protect collective bargaining and the socio-economic interests of employers in the scope of the Furniture Bargaining Council.
- 5.12 The provisions of sections 98 and 100 (b) and (c) of the Act apply, read with the changes required by the context, to the separate account referred to in sub-clause 5.9.
- 5.13 Any person may inspect the auditor's report, in so far as it relates to an account referred to in sub-clause 5.9.

- 5.15 If an employer or an employers' organisation or any interested person or organisation alleges that the representative employer's organisation is no longer a representative employers' organisation as envisaged in sub-clause 5.2 it must give the employers' organisation written notice of the allegation, and must allow the employers' organisation 90 days from the date of the notice to prove that it is a representative employers' organisation.
- 5.16 If, within the 90-day period, the representative employers' organisation fails to prove that it is a representative employers' organisation, the employer or employers' organisation or interested person or organisation making the allegation, must give the

employers' organisation which claims to be representative notice of its intention to request the Minister of Labour to withdraw the extension of this agreement to non-parties.

- 5.17 If the extension of this agreement to non-parties is withdrawn by the Minister of Labour for any reason, the provisions of sub-clauses 5.8 and 5.9 shall apply until all the Collective Bargaining Fees due up until the date of the withdrawal of this Agreement have been received and paid out in accordance with sub-clauses 5.8 and 5.9.

6. UNPAID COLLECTIVE BARGAINING FEES

- 6.1 Should any amounts due to the Council in terms of this agreement not be received by the Council by the 10th day of the month following the month in respect of which the amounts are payable, the employer shall forthwith be liable for and be required to pay interest on such amounts or on such lesser amounts that remain unpaid at a rate which does not exceed the maximum rate as prescribed by the Prescribed Rate of Interest Act, 1975 (Act 55 of 1975)(as amended), calculated from the 11th day of the month until the day upon which the payment is actually received by the Council. The Council shall be entitled at its absolute discretion to waive payment of such interest or part thereof in any individual instance.
- 6.2 In the event of the Council incurring any costs or becoming obliged to pay any collection costs and commission by reason of the failure of the employer to make any payment on or before the applicable due date, the employer shall then also be liable to forthwith pay all such collection costs and commission to the Council and the Council shall be entitled in its absolute discretion to allocate any payment received from such an employer firstly to such costs, collection commission and interest, and thereafter to the reduction of the unpaid Collective Bargaining Fees.
- 6.3 Disputes about the interpretation, application or enforcement of this agreement shall be resolved in accordance with the Dispute Resolution Procedure prescribed in the Furniture Bargaining Council's Main Collective Agreement.

7. EXEMPTIONS AND APPEALS

7.1 Exemptions Body and Independent Exemptions Appeal Body

An Exemptions Body and an Independent Exemptions Appeal Body is hereby established to hear and decide according to the prescribed criteria, all applications for exemptions from the provisions of this Collective Agreement and any appeal against-

- 7.1.1 the Bargaining Council's refusal of a party's or non-party's application for an exemption from the provisions of this Collective Agreement; or
- 7.1.2 the withdrawal of an exemption previously granted by the Bargaining Council.

7.2 Administration

7.2.1 Any natural person, establishment or other legal entity bound by this Collective Agreement may apply for an exemption from any of the provisions of this Collective Agreement or may lodge an appeal against-

7.2.1.1 the Bargaining Council's refusal of a party's or non-party's application for an exemption from the provisions of this Collective Agreement; or

7.2.1.2 the withdrawal of an exemption previously granted by the Bargaining Council.

7.2.2 An application for exemption or the lodging of an appeal shall be in writing. The application for exemption shall be completed on the Bargaining Council's prescribed application form obtainable from the Council's offices, fully motivated and served on the Bargaining Council with supporting documentation. An appeal shall be lodged with full motivation, heads of argument and with supporting documentation. The Applicant or the Appellant, depending on the nature of the process, shall satisfy the Body concerned that a proper application for exemption or appeal has been lodged with the appropriate body.

7.2.3 Whenever an employer, establishment or other legal entity applies for an exemption he, she or it shall consult with the affected workforce through their trade union representatives or, where there are no trade union representatives, with the affected workforce itself as to the need for the exemption and its effect on the affected employees and shall include in the application written proof of matters discussed during such consultation and written proof of the views expressed by the affected workforce during the consultation in this regard as well as the signed confirmation of all individually affected employees.

7.2.4 The Bargaining Council shall issue a notice of the outcome to the applicant of an exemption or to the appellant who lodged an appeal, setting out the following:

- 7.2.4.1 the full name of the applicant or appellant concerned;
- 7.2.4.2 the trading name of the applicant or appellant;
- 7.2.4.3 the exact provision(s) of this Collective Agreement from which the exemption or appeal has been granted or refused;
- 7.2.4.3 the conditions subject to which the exemption or appeal is granted;
- 7.2.4.4 the period for which the exemption or appeal is applicable; and/or
- 7.2.4.5 the outcome of the exemption or the appeal.

7.2.5 The Bargaining Council must ensure that:-

- 7.2.5.1 all notices relating to an exemption or an appeal must be served on the applicants or appellants personally; and
- 7.2.5.2 a copy of each notice relating to an exemption or an appeal must be kept on file by the Bargaining Council.

7.2.6 The Exemptions Body or the Independent Exemptions Appeal Body shall hear and decide all applications for exemptions or appeals lodged and shall notify the applicant or the appellant of the outcome thereof as soon as possible, but not later than 30 days from the date that the Council received the application for exemption or the appeal documentation.

7.2.7 The Bargaining Council may, on good cause shown, give the holder of an exemption 30 days' notice of its intention to apply to the Exemptions Body for the withdrawal of a particular exemption.

7.2.8 The following processes and criteria shall *inter alia* be considered when contemplating an application for exemption from the provisions of this Collective Agreement or an appeal lodged against the outcome of an exemption application or an application for the withdrawal of an exemption previously granted or when any appeal against a decision of the Council is considered:

7.2.8.1 **Processes:** Any employer, employee, trade union or employer's association or representative of the latter may at any point in time apply for an exemption from any of the provisions of this Collective Agreement or lodge an appeal against such outcome. The applicant is required to complete and submit in writing with the relevant office of the Council, a fully and properly completed prescribed application for exemption form, accompanied by all relevant supporting documentation. An appellant is required to submit a fully motivated written appeal with the relevant office of the Council, with heads of argument and supporting documentation.

7.2.8.2 **Criteria:** The Exemptions Body and/or the Independent Exemptions Appeal Body shall, without limiting its powers and authority, *inter alia* consider the following criteria to wit:

- 7.2.8.2.1 The financial and social implications on the applicants, appellants, competitors, employees and the Industry as a whole;
- 7.2.8.2.2 viability of the continued existence of the establishment;
- 7.2.8.2.3 the views expressed by the employees and/or the applicants, appellants and competitors;

- 7.2.8.2.4 the views and recommendations submitted by the bargaining council or any other person or body with an interest in the matter.
 - 7.2.8.2.5 the possibility of job losses if the exemption or appeal is granted or refused;
 - 7.2.8.2.6 the limitation on any employment opportunities if the exemption or appeal is granted or refused;
 - 7.2.8.2.7 any other relevant information that might have an impact on the outcome of either the exemption or the appeal;
 - 7.2.8.2.8 the applicant's or appellant's past record (if applicable) of compliance with the provisions of this Collective Agreement and/or certificates regarding exemptions or appeals.
 - 7.2.8.2.9 any special circumstances that may exist or any precedent that might be set;
 - 7.2.8.2.10 the interests of the Industry in relation to unfair competition, centralised collective bargaining as well as the economic stability of the Industry;
 - 7.2.8.2.11 the interests of the employees with regards to exploitation, job preservation, sound conditions of employment, potential financial benefits, health and safety and the possible infringement of basic rights; and
 - 7.2.8.2.12 the interests of the employer with regards to its financial stability, the impact on productivity, its future relationship with employees and recognised trade union operational requirements and the viability of the employer's business.
- 7.2.8.3 the outcome of an exemption application or an appeal should not contain terms and conditions that would have an unreasonably detrimental effect on the fair, equitable and uniform application in the Industry of any collective agreement concluded in the Bargaining Council;

7.2.8.4 no exemption or appeal outcome shall be granted for an indefinite period or as a total (blanket) exemption or appeal;

7.2.8.5 no exemption or appeal outcome should be granted retrospectively for any liabilities incurred by an employer in terms of this agreement, such as levies and/or contributions, which became payable by the employer to the Council prior to the date on which the application for such an exemption or an appeal was received by the Council.

PART A: SCOPE OF APPLICATION AND DEFINITIONS**1. SCOPE OF APPLICATION**

- 1 The terms of this Agreement shall be observed in the Pulp and Paper Sector of the Wood and Paper as defined in the registered scope of the National Bargaining Council of the Wood and Paper Sector in the Republic of South Africa
- 2 Notwithstanding the provisions of sub-clause 1, the terms of this Agreement shall –
 - (a) only apply in respect of employers and employees who fall within the bargaining unit in the Pulp and Paper Sector;
 - (b) not apply to full-time students and scholars who have obtained employment within the Industry during vacation periods.

2. PERIOD OF OPERATION OF AGREEMENT

- 1 This Agreement shall come into effect from *date of signature by the parties* until **31 December 2018**.
- 2 This agreement shall come into operation in respect of non- parties, on a date to be determined by the Minister of Labour and shall remain in force until force for the period ending **31 December 2018**.

PART B: WORKING TIME AND WAGE**CLAUSE: 3 WAGE AND DETERMINATION OF WAGES**

Substitute the following for the existing clause 4


- *1. The minimum wage for the Pulp and Paper Sector which an employer shall pay an employee falling within the Bargaining Unit shall be. R6 047 .00 per month until the expiry of this Agreement.
- 2 Wages will be calculated in accordance with the Collective Agreement on Conditions of Service for the Pulp and Paper Industry.

- 3 Every employer must pay each employee falling within the bargaining unit a wage increase of 7.75% across the board on actual rates with effect from the coming into operation of this Agreement until 30 June 2017.
- 4 The wages for employees as calculated in paragraph 3 above will apply until 30 June 2017.
- 5 Any calculation of wages must be based on the hourly rate of the employee's ordinary working hours and any fraction of a cent after completing the calculation must be adjusted to the nearest cent;
- 6 As a result of the different shift configurations in different workplaces and the reduction of working hours to 42 hours per week without loss of pay for employees in the Bargaining Unit and at no additional cost to the Employers in the Industry, the number of hours per week may differ from workplace to workplace, which, in turn, leads to different rates of basic pay per hour for different workplaces.
- 7 The basic hourly wage in each workplace is as calculated and agreed during the reduction to a 42-hour week.
- 8 The basic daily, weekly and monthly wage in each workplace is therefore as calculated during the reduction of working hours to a 42-hour week. "



ANNEXURE: Form for lodging a complaint with the Public Service Commission

Definitions

1. In these rules, unless the context indicates otherwise -

“applicable procedures” means all procedures issued in terms of legislation and all sub-ordinate legislation that regulates public administration and personnel practices in the Public Service;

“Commission” means the Public Service Commission established by section 196(1) of the Constitution;

“complainant” means a person who has lodged a complaint with the Commission;

“complaint” means a matter reported to the Commission in terms of section 196(4)(f)(i), (iii) and (iv) of the Constitution, 1996;

“Constitution” means the Constitution of the Republic of South Africa, 1996;

“department” means a national department, a national government component, the Office of a Premier, a provincial department or a provincial government component;

“employee” means a person contemplated in section 8 of the Public Service Act, but excludes a person appointed in terms of section 12A of the Act;

“personnel practices” means all those functions and activities executed to provide a service to employees such as recruitment, appointment, transfer and other career management objectives aimed at enhancing the well-being and effectiveness of the employees;

“public administration practices” means all those functions and activities executed by departments to provide effective and efficient services to any person, e.g. financial management, personnel provisioning and administration, supply chain management processes, service delivery, application of policies and procedures to attain proficiency;

“public service” means the public service contemplated in section 8 of the Public Service Act, 1994, as amended.

CHAPTER 1

PURPOSE AND APPLICATION OF RULES

Purpose and application of the rules

2. (1) The purpose of these rules is to provide for the investigation and evaluation of matters as contemplated in section 196(4)(f)(i), (iii) and (iv) of the Constitution, 1996.

(2) These rules are made under section 11 of the Public Service Commission Act, 1997 (Act No. 46 of 1997), which authorises the Commission to make rules regarding the matters to which section 196(4) of the Constitution relate.

(3) These rules do not apply to -

- (a) grievances of employees as contemplated in section 196(4)(f) (ii) of the Constitution, 1996, that fall within the ambit of the formal grievance procedure; and
- (b) misconduct appeals of employees that fall within the ambit of the formal disciplinary code and procedures for the public service.

CHAPTER 2

LODGING OF COMPLAINTS WITH THE COMMISSION

Matters that may be investigated and evaluated by the Commission

3. (1) The Commission may either of its own accord or on receipt of any complaint -

- (a) investigate and evaluate the application of personnel and public administration practices as contemplated in section 196(4)(f)(i) of the Constitution, 1996;
- (b) investigate and monitor adherence to applicable procedures in the public service as contemplated in section 196(4)(f)(iii) of the Constitution; and
- (c) advise national and provincial organs of state regarding personnel practices in the public service, including those relating to the recruitment, appointment, transfer, discharge and other aspects of the careers of employees in the public service as contemplated in section 196(4)(f)(iv) of the Constitution.

(2) Subject to these rules, a complainant may lodge a complaint with the Commission in respect of any matter contemplated in subrule (1), which may include a complaint regarding -

- (a) ethics related issues such as dishonesty, favouritism, abuse of power, improper personal gain and conflicts of interest;
- (b) accountability related issues such as appointment, procurement and financial irregularities, non-compliance with public service legislation and policy

- (including departmental policies), lack of access to information and lack of confidentiality;
- (c) service delivery and professionalism related issues such as bias/impartiality, unfairness, discrimination and prejudice;
 - (d) performance related issues such as incapacity, incompetence, lack of training/ capacitating and lack of representivity; and
 - (e) policy related issues such as the non-existence of policies and policies that may be in conflict with legislation.

Matters that will not be investigated by the Commission

4. (1) The following matters that fall outside the jurisdiction of the Commission will not be investigated;

- (a) corruption and maladministration;
- (b) conduct of private medical practitioners;
- (c) the outcome of and delays in court cases;
- (d) public entities as listed in Schedules 2 and 3 of the *Public Finance Management Act, 1999*;
- (e) former public servants;
- (f) private sector bargaining councils and labour unions;
- (g) conduct of Magistrates during court cases;
- (h) conduct of Sheriffs of the Court; and
- (i) private businesses.

(2) The Commission will also not investigate a complaint if any of the following applies:

- (a) A complaint already investigated by the Commission;
- (b) A complaint lodged with the Commission that has already been lodged with another institution that would lead to a duplication of efforts or resources;
- (c) A complaint that has been investigated by another institution will not be reviewed by the Commission;
- (d) Instances where the Commission establishes non-disclosure by the complainant of having referred the complaint to another institution;
- (e) A complaint that can more appropriately be dealt with by another institution;
- (f) An anonymous complaint in which critical factual gaps exist, rendering the likelihood of a successful conclusion unlikely;
- (g) A complaint of a frivolous, vexatious or tactical nature or seeking to abuse the Public Service Commission Rules on conducting investigations;
- (h) A complaint not meeting the criteria set out in the Public Service Commission Rules on conducting investigations; and
- (i) Instances of "Forum Shopping".

Procedure to be followed before lodging of complaints with the Commission

5. (1) Before lodging a complaint with the Commission a complainant may first endeavour to resolve the complaint with the relevant department.

(2) If the complainant is still not satisfied, or if the complainant is of the view that the complaint should be referred directly to the Commission for investigation, she or he may then lodge that complaint with the Commission via the

national office or the relevant provincial office, in which case reasons must be provided to the Commission in both instances.

(3) When a complainant's lodging of a complaint directly with the Commission is not accepted by the Commission, the complainant must be informed accordingly within 21 days from the date on which the Commission took its decision.

Timeframes for lodging of complaints with the Commission

6. (1) A complainant must lodge a complaint with the Commission within 12 months from the date on which the incident occurred.

(2) The Commission may, on good cause shown, decide whether to investigate a complaint lodged after the expiry of the period of 12 months referred to in subrule (1).

(3) In deciding whether or not to investigate a complaint lodged after the 12 month period, the Commission will consider the following:

- (a) the reasons for the late lodging of the complaint, if any;
- (b) the extent of the prejudice likely to be suffered if the complaint is not investigated by the Commission; and
- (c) any other circumstances/relevant factors which warrant condonation of such late lodging of a complaint.

(4) When a complainant's lodging of a complaint after the expiry of the period of 12 months referred to in subrule (1) is not accepted by the Commission, the complainant must be informed accordingly within 21 days from the date on which the Commission took its decision.

Methods that may be used when lodging complaints with the Commission

7. (1) A complainant may lodge a complaint with the Commission by following any one of the following methods:

- (a) By the completion of the form for lodging a complaint with the Commission, as set out in Annexure A, which form is available online on the Website of the Commission (www.psc.gov.za) or at any Office of the Commission.

- (b) By means of a letter or statement addressed to the Commission which may be posted, e-mailed to info@opsc.gov.za or faxed to the Commission.
- (c) By contacting any Office of the Commission telephonically, in which case the form referred to in subrule (1)(a), must be completed by the relevant Office of the Commission on behalf of the complainant.
- (d) By lodging a complaint verbally in person with any Office of the Commission, in which case the form referred to in subrule (1)(a), must be completed and signed by the complainant.

(2) A complainant may lodge a complaint with the Commission in any of the official languages referred to in section 6(1) of the Constitution.

Information required when lodging complaints with the Commission

8. (1) The following information should be contained in the complaint that is lodged with the Commission:

- (a) the full names of the complainant;
- (b) the physical and postal address of the complainant;
- (c) the telephone number, facsimile number and e-mail address (if available) of the complainant;
- (d) the place and date of the occurrence of the complaint;
- (e) the names and designations of employees involved;
- (f) the department involved;
- (g) the nature of the complaint, which should contain the background and history of the complaint;
- (h) the steps, if any, that have been taken in trying to resolve the complaint;
- (i) the names and particulars of the employees of the department who have been dealing with the complaint (if applicable);
- (j) an indication whether or not the complaint was lodged with any other department or institution/authority and, if so, the outcome thereof;
- (k) the names, contact numbers and addresses of any person who could provide information relevant to the complaint;
- (l) the outcome sought to be achieved by the investigation; and
- (m) supporting documentation relevant to the complaint, if any.

(2) Upon receipt of a complaint, the Commission may conduct a preliminary investigation, if necessary, in order to determine whether there are grounds for a more in-depth investigation to be conducted.

Complaints lodged with the Commission anonymously

9. (1) The Commission is not obliged to investigate a complaint lodged with it anonymously.

(2) The Commission may decide to investigate such a complaint after taking into consideration, amongst others, the following factors:

- (a) The magnitude, seriousness and complexity of the allegations;
- (b) whether or not critical factual gaps exist that may render the likelihood of a successful investigation and conclusion unlikely; and
- (c) the supporting documentation accompanying the complaint, if any.

CHAPTER 3

INVESTIGATION OF COMPLAINTS BY THE COMMISSION

Registration and allocation of complaints received

10. The Commission will upon receipt of a complaint –
- (a) allocate a reference number to the complaint;
 - (b) assign the complaint to an investigating officer;
 - (c) acknowledge receipt of the complaint within 48 hours from the date of receipt of the complaint by the investigating officer;
 - (d) ensure that the information provided with the complaint complies with the provisions of rule 8;
 - (e) follow up with the complainant to obtain essential information and/or documentation, if required, in those instances where the contact details of the complainant are provided and where the complaint was lodged by any of the methods listed in rule 7(1);
 - (f) assess whether the Commission has the jurisdiction to investigate the complaint; and

- (g) inform the complainant in writing, within a reasonable period but not later than 21 days after either the date of receipt of the complaint by the investigating officer or the date on which the non-disclosure of the referral of the complaint to another institution was established by the Commission, that the complaint will –
 - (i) not be investigated by the Commission in which case reasons must be provided therefor in accordance with rule 4; or
 - (ii) be investigated by the Commission in which case the name and contact particulars of the investigating officer will be provided.

Determine the scope of the investigation and additional information required

11. (1) The Commission will determine whether the complaint will be dealt with as a complaint for early resolution or as a complaint for investigation by developing terms of reference for the investigation.

(2) Early resolution complaints:

- (a) The Commission will close/refer to the appropriate institution an early resolution complaint when the following applies:
 - (i) The complaint falls outside the jurisdiction of the Commission as referred to in rule 4(1).
 - (ii) The conditions referred to in rule 4(2).
 - (iii) Any other reason at the discretion of the Commission.
- (b) The Commission will investigate an early resolution complaint where there is a possibility that the complaint can be resolved within 45 days from the date of receipt of all relevant documentation.
- (c) The Commission will inform a complainant of the closure/referral/outcome of an early resolution complaint within 10 days from the date on which the complaint was closed/finalised/referred.

(3) **Complaints for investigation with terms of reference:**

- (a) The Commission will deal with a complaint as an investigation by developing terms of reference for the investigation as determined by the magnitude, seriousness, complexity and sensitivity of the allegations.
- (b) The Commission will request additional information from the complainant and/or the department(s) involved in order to enable the Commission to do a proper analysis and arrive at informed findings on the complaint, by means of –
 - (i) a letter directed to the executive authority/head of the department regarding the complaint and the conducting of the investigation by the Commission as well as requesting the relevant documentation;
 - (ii) telephonic conversations confirmed by e-mails or faxes; and
 - (iii) through consultations, interviews, visits and in-loco inspections, which will be properly documented.
- (c) The Commission will consider issuing summons in terms of section 10 of the *Public Service Commission Act, 1997*, in cases where the relevant department is not cooperating in providing the requested information or where a person is withholding material evidence pertaining to the investigation.

Conducting an investigation and compiling a report

12. (1) With regard to conducting an investigation, the Commission –
- (a) will approve the report within three months from the date of receipt of all relevant documentation;
 - (b) may proffer advice, make recommendations and/or issue directions based on the findings contained in the report;

- (c) will provide the executive authority/head of the department with an opportunity to comment on the findings made by the Commission within 30 days from the date of receipt of the provisional report;
- (d) will consider the comments from the executive authority/head of the department on the findings made by the Commission;
- (e) will provide the executive authority/head of the department with a final report containing findings, which may also contain advice and/or recommendations and/or directions, for implementation of the recommendations and/or directions and to provide feedback to the Commission within 60 days from the date of receipt of the report. If the executive authority/head of the department decides not to implement the Commission's recommendations, reasons must be provided to the Commission;
- (f) will follow up with the executive authority/head of the department on the implementation of recommendations and/or the issuing of directions contained in the report; in the event that no feedback is received within the 60 days;
- (g) shall report to the legislature in terms of section 196(4)(f)(i) of the Constitution, 1996 ; and
- (h) shall treat the information received as a result of a complaint lodged and an investigation conducted as confidential and shall take reasonable steps to safeguard confidentiality whilst conducting the investigation and compiling the report.

(2) Once the executive authority/head of the department has considered the report and made a decision in respect of the Commission's recommendations/directions the executive authority/head of the department may decide on the dissemination of copies of the report to affected and interested parties.

Withdrawal of rules and transitional measures

13. (1) The Rules published by Government Notice 977 of 19 July 2002 is hereby withdrawn.

(2) Any investigation instituted or complaint lodged under the law mentioned in subrule (1) must be finalised under that law as if that law has not been withdrawn by these Rules.

Short title and commencement

14. These Rules are called the Public Service Commission Rules on conducting investigations and shall come into operation on the date of publication in the Government Gazette.
