

# COMPOSITE INVITATION TO APPLY INDIVIDUAL COMMERCIAL FREE TO AIR TELEVISION BROADCASTING SERVICE AND RADIO FREQUENCY SPECTRUM LICENCE FOR MUX 3 FREQUENCIES

# **1. INTRODUCTION**

The Independent Communications Authority of South Africa ("the Authority"), hereby invites applications for Individual Commercial Free To Air Television Broadcasting Service Licence(s) and the applicable Radio Frequency Spectrum Licence(MUX 3 frequencies) in terms of sections 9 and 31(3)(a) of the Electronic Communications Act, 2005 (Act No. 36 of 2005) ("the Act"), as amended, read with regulation 7 of the Radio Frequency Spectrum Regulations, 2015, as amended by government gazettes No. 38754 of 2015 and No. 40436 of 2016, for the provision of free-to-air television broadcasting services (the Radio Frequency Spectrum Regulations).

All applications will be considered based on the requirements of the Act, the applicable regulations and this Invitation to Apply ("ITA").

This ITA applies to both the service and spectrum licence applications.

#### **SCHEDULE A**

- 1. Applications must be made in writing.
- An Applicant must answer all questions set out in this application form in full. If any question is considered not applicable, mark it as "N/A" and provide further explanation as to why it is not applicable.
- 3. An Applicant must submit one original application clearly marked as such, together with fifteen (15) hard copies, and three (3) soft copies of the application, all of which must be received by the Authority by the closing date indicated in paragraph 18 below.
- 4. In terms of section 4D of the ICASA Act, An Applicant may request that any part of the application be treated as confidential. The request for confidentiality must be made in terms of section 4D of the ICASA Act and should be accompanied by a written statement explaining why the specific information should be treated as confidential. Requests for confidentiality will be considered in accordance with the provisions of section 4D of the ICASA Act.
- 5. The Authority will make a determination on the request for confidentiality within fourteen (14) working days of receiving the request and will communicate its decision to the respective Applicant.
- In the event that the request for confidentiality is refused, the Applicant may choose to withdraw the information in respect of which confidentiality is requested.
- Confidential information should be clearly marked as such and submitted separately, but together with the original application, comprising the original thereof, fifteen (15) hard copies and three (3) soft copies.

- An application must be permanently bound (using either heat or spiral binding).
- An application must have a cover page indicating the title of the ITA, name of the Applicant, the proposed name of the broadcasting service and year of application.
- The page(s) immediately following the cover must be the contents page(s), which shall detail each section of the application and corresponding page numbers.
- 12. An application, including the appendices and schedules, must be sequentially numbered starting with the page immediately following the contents page(s) as page 1 and ending with the very last page of the application.
- 13. In the event that the Applicant has to submit its application in more than one part or volume, each part or volume must have a cover page bearing all the details set out above. In this case the cover page must specify the number of the part or volume (i.e. Part One, Part Two or Volume One, Volume Two). Each volume or part must also have the full set of contents pages and be sequentially numbered as indicated above.
- 14. In addition to the application for an Individual Commercial Free-To-Air Television Broadcasting Service Licence, an Applicant MUST also apply for a Radio Frequency Spectrum Licence for MUX 3 broadcasting frequencies as specified in Annexure G or the Latest Version of the Terrestrial Broadcasting Frequency Plan 2013.

(**R600 000.00**). The application fee is in respect of the commercial television broadcasting service licence and the radio frequency spectrum licence.

- The closing date for the submission of applications shall be 11:00 am, South African time, on <u>30 August 2017.</u>

# 19. <u>An application received after the closing date and time will</u> <u>neither be accepted nor considered by the Authority.</u>

- 20. The licensing mechanism will be undertaken in two phases:
  - Phase 1: Consideration of the applications for an Individual Commercial Free to Air Television Broadcasting Service licence;
  - 20.2. Phase 2: Consideration for a Radio Frequency Spectrum Licence for MUX 3 frequencies.

- 21. The minimum requirements for the consideration for a Radio Frequency Spectrum Licence for MUX 3 frequencies are as follows:
  - 21.1. An Applicant must have fulfilled all the requirements for, and be eligible to be issued with an Individual Commercial Free to Air Television Broadcasting Service licence in Phase 1 of the licensing process;
  - 21.2. At the time of submission of its application, an Applicant must have a minimum of 30% equity ownership held by persons from historically disadvantaged groups.
- 22. The Authority reserves its right not to grant a licence should an Applicant not meet the requirements as set out in this ITA.
- 23. In addition to the terms and conditions set out in this section, Applicants are advised to apprise themselves fully of the provisions of the Act, ICASA Act, Broadcasting Act and all regulations promulgated by the Authority that may be applicable to this ITA.
- 24. Failure to comply with any of the above requirements, the provisions of the Act and/or relevant regulations will render the application subject to disqualification.
- 25. All applicants shall carry their own costs in responding to the ITA.

### SCHEDULE B: AMENDMENTS TO THE APPLICATION

- Amendments to applications received in terms of this ITA will be considered in terms of the provisions of Regulation 6 of the Processes and Procedures Regulations or, where applicable, Regulation 8 of the Radio Frequency Spectrum Regulations.
- 2. In instances where the information included in an application changes at any time after submission of the application but before the Authority makes a decision, the Applicant must notify the Authority of such changes and request an amendment to its application in writing within fourteen (14) days of such change<sup>1</sup>.
- The Authority will, after being notified by an Applicant of any changes to the applications, determine whether the changes;
  - 3.1. unfairly prejudice other interested parties;
  - 3.2. impede the expeditious and proper consideration of the application; or
  - 3.3. materially change the application as to constitute a new application.<sup>2</sup>
- 4. The Authority will then notify the Applicant of its decision to either grant or refuse the request for amendment. In the event that the request for amendment is granted, the Authority may publish a notice in the Government Gazette inviting interested parties to submit written representations in relation to the amendment within the period stipulated in the notice.
- 5. Notwithstanding anything in this clause, an Applicant may not change its shareholding, resulting in a reduction of equity ownership held by Historically Disadvantaged Groups (HDGs) in the Applicant below the 30% threshold.

  - 1.4. at any point during the application process, less than 30% equity ownership held by persons from Historically Disadvantaged Groups (HDGs);
  - 1.5. submitted an application which contains false or misleading information;
  - 1.6. colluded or attempted to collude, with another Applicant;
  - obtained or acquired confidential information relating to another Applicant without consent from the Authority and/or the owner of such confidential information; or
  - has failed to comply with the terms and conditions of the ITA, the provisions of the Act, ICASA Act, Broadcasting Act and/or all relevant Regulations.
