I, John Harold Jeffery, Deputy Minister of Justice and Constitutional Development, acting under the power delegated to me by the Minister of Justice and Constitutional Development, under section 2 of the Small Claims Courts Act, 1984 (Act No. 61 of 1984), hereby -

- (a) (i) establish a Small Claims Court for the adjudication of claims for the area of Senekal, consisting of the district of Senekal;
 - (ii) determine Senekal to be the seat of the said Court; and
 - (iii) determine Senekal and Paul Roux to be the places in that area for the holding of sessions of the said Court;
- (b) (i) establish a Small Claims Court for the adjudication of claims for the area of Winburg, consisting of the district of Winburg;
 - (ii) determine Winburg to be the seat of the said Court; and
 - (iii) determine Winburg to be the place in that area for the holding of sessions of the said Court; and
- (c) withdraw Government Notice No. 705 of 12 September 2014.

Despite the withdrawal of Government Notice No. 705 of 12 September 2014, any claim emanating from the district of Winburg which has already been instituted in the Small Claims Court of Senekal prior to the publication of this Government Notice, shall be continued and concluded in the Small Claims Court of Senekal as if this Government Notice has not been published.

ALTERATION OF THE AREA FOR WHICH THE SMALL CLAIMS COURT FOR BLOEMFONTEIN WAS ESTABLISHED AS PUBLISHED IN GOVERNMENT NOTICE NO. 2096 OF 20 SEPTEMBER 1985, AS AMENDED BY GOVERNMENT NOTICE NO. 2113 OF 30 AUGUST 1991, AS AMENDED BY GOVERNMENT NOTICE NO. 1743 OF 26 JUNE 1992, AS AMENDED BY GOVERNMENT NOTICE NO. 395 OF 17 MARCH 1995, AS AMENDED BY GOVERNMENT NOTICE NO. 570 OF 15 JULY 2011, AS AMENDED BY GOVERNMENT NOTICE NO. 682 OF 26 AUGUST 2011, AS AMENDED BY GOVERNMENT NOTICE NO. 820 OF 12 AUGUST 2012: ESTABLISHMENT OF A SMALL CLAIMS COURT FOR THE AREA OF REDDERSBURG

I, John Harold Jeffery, Deputy Minister of Justice and Constitutional Development, acting under the power delegated to me by the Minister of Justice and Constitutional Development, under section 2 of the Small Claims Courts Act, 1984 (Act No. 61 of 1984), hereby -

- (a) Alter the area for which the Small Claims Court of Bloemfontein was established by excising therefrom the district of Reddersburg;
- (b) amend Government Notice No. 2096 of 20 September 1985 to reflect that the area of the Small Claims Court of Bloemfontein consists of the district of Bloemfontein;
- (c)
 - (i) establish a Small Claims Court for the adjudication of claims for the area of Reddersburg, consisting of the district of Reddersburg;
 - (ii) determine Reddersburg to be the seat of the said court, and
 - (iii) determine Reddersburg to be the place in that area for the holding of sessions of the said court.

Notwithstanding the alteration of the area of jurisdiction and amendment of the Government Notice, contemplated in paragraphs (a) and (b) above, the adjudication of claims from the district of Reddersburg which have already been instituted in the Small Claims Court of Bloemfontein, shall be continued and concluded in the Small Claims Court of Bloemfontein as if this Government Notice has not been published.

ESTABLISHMENT OF SMALL CLAIMS COURTS FOR THE AREAS OF WELKOM, HENNENMAN, VIRGINIA, VENTERSBURG, ODENDAALSRUS AND THEUNISSEN AND WITHDRAWAL OF GOVERNMENT NOTICE NO. 30 OF 24 JANUARY 2014

I, John Harold Jeffery, Deputy Minister of Justice and Constitutional Development, acting under the power delegated to me by the Minister of Justice and Constitutional Development, under section 2 of the Small Claims Courts Act, 1984 (Act No. 61 of 1984), hereby -

- (a) (i) establish a Small Claims Court for the adjudication of claims for the area of Welkom, consisting of the district of Welkom;
(ii) determine Welkom to be the seat of the said Court; and
(iii) determine Welkom to be the place in that area for the holding of sessions of the said Court.
- (b) (i) establish a Small Claims Court for the adjudication of claims for the area of Hennenman, consisting of the district of Hennenman;
(ii) determine Hennenman to be the seat of the said Court; and
(iii) determine Hennenman to be the place in that area for the holding of sessions of the said Court.
- (c) (i) establish a Small Claims Court for the adjudication of claims for the area of Virginia, consisting of the district of Virginia;
(ii) determine Virginia to be the seat of the said Court; and
(iii) determine Virginia to be the place in that area for the holding of sessions of the said Court.
- (d) (i) establish a Small Claims Court for the adjudication of claims for the area of Ventersburg, consisting of the district of Ventersburg;
(ii) determine Ventersburg to be the seat of the said Court; and
(iii) determine Ventersburg to be the place in that area for the holding of sessions of the said Court.

- (e) (i) establish a Small Claims Court for the adjudication of claims for the area of Odendaalsrus, consisting of the district of Odendaalsrus;
- (ii) determine Odendaalsrus to be the seat of the said Court; and
- (iii) determine Odendaalsrus to be the place in that area for the holding of sessions of the said Court.
- (f) (i) establish a Small Claims Court for the adjudication of claims for the area of Theunissen, consisting of the district of Theunissen;
- (ii) determine Theunissen to be the seat of the said Court; and
- (iii) determine Theunissen to be the place in that area for the holding of sessions of the said Court.
- (d) withdraw Government Notice No. 30 of 24 January 2014.

Despite the withdrawal of Government Notice No. 30 of 24 January 2014, any claim emanating from the districts of Odendaalsrus and Theunissen which has already been instituted in the Small Claims Court of Welkom prior to the publication of this Government Notice, shall be continued and concluded in the Small Claims Court of Welkom as if this Government Notice has not been published.
