Invitation for public comments on Eskom's revenue application for 2018/19

The National Energy Regulator of South Africa (NERSA) is a regulatory authority established as a juristic person in terms of Section 3 of the National Energy Regulator Act, 2004 (Act No. 40 of 2004). NERSA's mandate is to regulate the electricity, piped-gas and petroleum pipelines industries in terms of the Electricity Regulation Act, 2006 (Act No. 4 of 2006), Gas Act, 2001 (Act No. 48 of 2001) and Petroleum Pipelines Act, 2003 (Act No. 60 of 2003).

The Energy Regulator received Eskom's revenue application for 2018/19 on 25 August 2017.

The Energy Regulator will assess Eskom's application following due regulatory processes:

Activity	Timeframe
1. Publish Eskom's application on NERSA website for stakeholder comments	13 September 2017
2. Closing date for stakeholder comments	13 October 2017
3. Public Hearings on Eskom's revenue application for 2018/19	30 October 2017 to 16 November 2017 (see details below)
4. Energy Regulator decision on Eskom's revenue application for 2018/19	07 December 2017
