APPLICATION FOR THE RENEWAL OF AN INDIVIDUAL COMMERCIAL SOUND BROADCASTING SERVICE AND SPECTRUM LICENCE BY RISE BROADCAST (PTY) LTD

- 1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received an application to renew Rise Broadcast (Pty) Ltd ("Rise FM")'s Individual Commercial Sound Broadcasting Service Licence and Individual Commercial Sound Broadcasting Spectrum Licence lodged in terms of Regulation 10 of the Processes and Procedures Regulations for Individual Licences and Special Temporary Authorisations of 2010 together with Amendment Individual Processes and Procedures Regulations 2015, and section 11 of the Electronic Communications Act, No 36 of 2005 ("EC Act"). In terms of section 11(3) read with section 9(2)(a) of the EC Act, the Authority is required to give notice of the application in the Gazette and invite interested persons to submit written representations in relation to the application.
- 2. The application, relevant schedule and any representations received pursuant thereto would be made available and be open for inspection by interested parties in the Authority's library during the Authority's normal office hours.
- Interested parties are invited to lodge written representations in relation to the application within fourteen (14) working days from the date of publication of this notice in the Government Gazette. Persons who lodge representations must also indicate whether they wish to make oral submissions should the Authority decide to hold a public hearing in respect of the application.
