

The Authority hereby makes the following changes on the published notice in relation to Rhythm FM as contained in the Government Gazette dated 22 December 2017: Table of proposed technical amendments of Rhythm FM's publication is amended to state that the Maximum ERP for Butterworth site is 15 kW instead of 1 kW and for the Queenstown site's ERP is 4.8 kW instead of 4 kW.
