I, Nhlanhla Musa Nene, Minister of Finance, hereby, after having taken into account the financial implications for the state, under section 12R(3) of the Income Tax Act, 1962 (Act No. 58 of 1962), read with paragraph (b) of the definition of “qualifying company” in section 12R(1) of that Act, approve, as a special economic zone, for purposes of section 12R of that Act, Coega Special Economic Zone, as designated by the Minister of Trade and Industry in terms of notice 505 published in the *Government Gazette* number 40883 of 02 June 2017, which is situated on Farms Grassridge and Tankatara to the North, Farm Melville and the Indian Ocean to the East, the Port of Ngqura, the residential areas of St Georges Strand, Wells Estate and Markman Industrial to the South and Farms Coega Kop and Welbedachts Fontein to the West, with a total land area of 9003 hectares, consisting of the following zones:

Zone 1N

Situated on erf 294 Coega, bounded by the Port of Ngqura to the North and East, Neptune Road to the South and N2 national road to West;

Zone 1S

Situated on the outer boundary of erf 233 Coega, bounded by Neptune road to the North, Port of Ngqura to the East, St Georges Strand to the South and N2 national road to the West;

Zone 2

Situated on erven 226 and 229 Coega, bounded by Neptune Road to the North, N2 national road to the East, Wells Estate to the South and Markman Industrial to the West;

Zones 3 and 4


Dube AgriZone 1

Zone 1 A

Situated on part of erf number 56421, bounded by the Mvubukazi River to the West, the Indian Ocean to the South, Ngqenga River to the East and Harbour Arterial Road to the North;


