- 6. All written representations submitted to the Authority pursuant to this notice shall be made available for inspection by interested persons from 22nd of January 2019 at the ICASA Library or website and copies of such representations and documents will be obtainable on payment of a fee.
- 7. Where persons making representations require that their representation, or part thereof, be treated confidential, then an application in terms of section 4D of the ICASA Act, 2000 (Act No. 13 of 2000) must be lodged with the Authority. Such an application must be submitted simultaneously with the representation on the draft regulations and plan. Respondents are requested to separate any confidential material into a clearly marked confidential annexure. If, however, the request for confidentiality is refused, the person making the request will be allowed to withdraw the representation or document in question. The guidelines for confidentiality request are contained in Government Gazette Number 41839 (Notice 849 of 2018).
