The Department of Transport and the Road Traffic Management Corporation (RTMC) published the National Road Traffic Law Enforcement Code (NRTLEC) in Government Gazette No. 42230 of 15 February 2019. Section 32 of the RTMC Act, 20 of 1999 requires that the RTMC develops the Code and publish it for comment.
