PUBLICATION OF EXPLANATORY SUMMARY OF THE MILITARY DISCIPLINE BILL, 2019

The Minister of Defence and Military Veterans intends introducing the Military Discipline Bill, 2019, ("the Bill") in the National Assembly. The explanatory summary of the Bill is hereby published in accordance with Rule 276 of the Rules of the National Assembly.

The Bill seeks to —

- (a) provide for an effective administration of the military justice system and maintenance of discipline in the Defence Force;
- (b) establish and regulate military courts and appointment of judicial officers and court officials;
- (c) provide for the appointment the Judge Advocate General and Provost Marshal General of the Defence Force:
- (d) provide for administrative processes;
- (e) repeal the Military Supplementary Measures Act, 1999; and
- (f) provide for matters connected therewith.
