

AMENDMENT OF PUBLIC SERVICE REGULATIONS, 2016

SCHEDULE

Definition

1. In this Schedule "the Regulations" means the Public Service Regulations,

2016 published in Government Notice No. R. 877 of 29 July 2016.

Amendment of regulation 100 of the Regulations

- 2. Regulation 100 of the Regulations is hereby amended—
- An Advisory Body may consist of up to [five] ten persons appointed in writing by the Minister.

Amendment of regulation 103 of the Regulations

- 3. Regulation 103 of the Regulations is hereby amended—
- (1) A member of the Advisory Body shall be remunerated [according] equivalent to the scales <u>applicable to members of a Committee of Inquiry as determined</u>, from time to time, by the National Treasury in terms <u>of regulation 20.2.2</u> of the Treasury Regulations.
