FOODSTUFFS, COSMETICS AND DISINFECTANTS ACT, 1972 (ACT NO. 54 OF 1972)

THE REGULATIONS UNDER THE FOOD, DRUGS AND DISINFECTANTS ACT, 1929 (ACT NO. 13 OF 1929): REPEAL

The Minister of Health, has in terms of section 15 (1) of the Foodstuffs, Cosmetics and Disinfectants Act, 1972 (Act No. 54 of 1972) hereby repeals the Regulations Relating to the following products promulgated under the repealed Food, Drugs and Disinfectants, 1929, (Act No. 13 of 1929), and published under Government Notice No. 575 of 28 March 130 with immediate effect:

- (a) Regulation11: Ice cream and ice-cream products
- (b) Regulation14: Meat and fish and their preparations: Edible fats and edible oils-(Except 14(4)(iii))
- (c) Regulation15: Tea
- (d) Regulation16: Coffee, coffee mixtures and preparations of coffee
- (e) Regulation17: Chicory
- (f) Regulation 18: Cocoa and chocolate
- (g) Regulation 27: Sugar, confectionery, dextrose and icing sugar
- (h) Regulation39 bis: Edible gelatin
