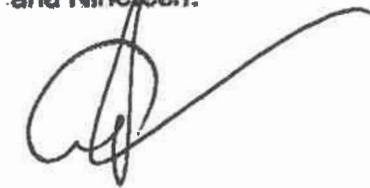
PROCLAMATION NO. 47 OF 2019

**AMENDMENTS TO THE TERMS OF REFERENCE OF THE A COMMISSION OF
INQUIRY INTO ALLEGATIONS OF IMPROPRIETY REGARDING THE PUBLIC
INVESTMENT CORPORATION**

Under the powers vested in me by section 1 of the Commissions Act, 1947 (Act No. 8 of 1947) I hereby, with effect from 31 July 2019, amend the Terms of Reference of the Commission of Inquiry of into allegations of impropriety regarding the Public Investment Corporation (PIC) published under Proclamation No. 21 of 2019 in the Government Gazette No. 42384 of 4 April 2019 as indicated in the attached Schedule.

Definition

1. In this Proclamation "Terms of Reference" means the terms of reference published under published under Proclamation No. 30 of 2018 published in the Government Gazette No. 41979 of 17 October 2018 and amended by Proclamation No. 21. of 2019 in the Government Gazette No. 42384 of 4 April 2019.

Amendment of the Terms of Reference

2. Paragraph 3 of the Terms of Reference is hereby amended as indicated below:

"3. The Commission must submit-

3.1. an interim report to the President by not later than 15 February 2019; and

3.2. a final report by not later than ~~[31 July 2019]~~ 31 October 2019."

4. The amendments to the Terms of Reference published under this Proclamation shall come into operation on 31 July 2019.
