APPOINTMENT OF A COMMITTEE

- 1. By virtue of the powers vested in me in terms of section 14 of the International Trade Administration Act, 2002 (Act No. 71 of 2002), I, Ebrahim Patel, Minister of Trade and Industry hereby appoint the persons listed below as members of the Steel Committee of the International Trade and Administration Commission of South Africa to monitor and make recommendations to the Commission in respect of:
 - 1.1. The impact of the changes in import tariffs and trade remedies applicable to the primary steel industry on:
 - 1.1.1. downstream users in the steel industry;
 - 1.1.2. the pricing of the products of producers in the primary steel industry to downstream users; and
 - 1.1.3. the steel industry generally.
 - 1.2. The commitments made by applicants for such changes in import tariffs and their impact on job creation and job retention, industrial output, investments in plant, equipment, skills, research, development, technology and economic investments;
 - 1.3. Jobs in the full steel industry value chain; and
 - 1.4. Import and export trends in the steel industry value chain.
- 2. The Committee was established in terms of Government Notice No. 40058 for a period of 5 years which started on 10 June 2016. The Commission will comprise the individual

members referred to below who are appointed from the date of gazetting of this notice until 9 June 2021:
