FURTHER EXTENSION OF THE CLOSING DATE FOR SUBMISSION OF WRITTEN REPRESENTATIONS TO THE DRAFT FINDINGS DOCUMENT IN THE INQUIRY INTO SUBSCRIPTION TELEVISION BROADCASTING SERVICES

- 1. The Independent Communications Authority of South Africa ("the Authority") published the Draft Findings Document pursuant to the Inquiry into Subscription Television Broadcasting Services in terms of section 4B of the ICASA Act, read with section 67(4) of the Electronic Communications Act, 36 of 2005 ("the EC Act") in Government Gazette No. 42391 of 12 April 2019, calling upon interested parties to make written representations on the Draft Findings Document within 45 days of its publication i.e. by 21 June 2019.
- In terms of the notice of extension published on 7 June 2019 ("the Initial Notice") the Authority extended the closing date for the

submission of written representations from 21 June 2019 to 27 August 2019.

- 3. Following the Initial Notice, the Authority uploaded additional documents and/or information underlying the preliminary conclusions and findings reached in the Draft Findings Document to its website on 10 June and 10 July 2019 for access by all interested parties.
- 4. Pursuant to the publication of the additional underlying documents and/or information referred to above, the Authority has decided to further extend the closing date for submission of written representations to the Draft Findings Document.
- 5. The closing date is hereby extended from 27 August 2019 to 4 October 2019 at 16:00.
