**INVITATION TO NOMINATE CANDIDATES FOR THE SOUTH AFRICAN
BROADCAST PRODUCTION ADVISORY BODY**

I, Ms Stella Ndabeni- Abrahams, Minister of Communications hereby invite interested parties to nominate *candidate(s)* to be considered for appointment to the South African Broadcast Production Advisory Body (SABPAB), as empowered by section 38 of the Broadcasting Act 4 of 1999.

The SABPAB will advise on how the development, production and display of local television and radio content can be supported. As part of this effort the SABPAB will make recommendations to the Minister to enable the Minister to determine policy and strategies to give effect to the production and display of local content; financing strategies to support the production of local content; supply-side measures and initiatives to support the production of local content; and policies to enhance the production of local content for the multichannel and digital broadcasting environment.

Viewed collectively, the SABPAB shall comprise representatives of a cross section of stakeholders including: government, the regulatory bodies, broadcasting sector, content production, intellectual property, copyrights, broadcast cybersecurity, cinematographic sectors and consumer bodies.

Relevant curricula vitae for nominated candidates, including the following information, should be provided: Identity number; gender; race; designation and responsibilities; contact details (postal and email addresses, and telephone and fax numbers); qualifications and field; current and past service on boards; areas of expertise; names and contact details of two referees.

Nominees should also confirm their availability to serve in the SABPAB. Nominations should be submitted to the Minister of Communications no later than **31 September 2019** for the attention of the Acting Director -General of Communications, addressed to Ms Ntombi Makwetu, by email to SABPABnominations@doc.gov.za.
