**NOTICE IN TERMS OF SECTION 136 (1) OF THE FIREARMS CONTROL ACT, 2000  
(ACT NO. 60 OF 2000)**

By virtue of the powers vested in me by section 136 (1) of the Firearms Control Act, 2000 (Act No. 60 of 2000), I Khehla John Sitole, National Commissioner of the South African Police Service, in my capacity as Registrar of Firearms as contemplated in section 123 of the said Act, hereby give notice that the State intends to destroy all firearms, ammunition as well as firearm parts, listed in the website below, that were voluntarily surrendered to or forfeited to the State.

Interested parties can visit the South African Police Service website at <http://www.saps.gov.za>, for a list of firearms, ammunition of firearms parts intended to be destroyed by the State.

In terms of section 136 (2) of the Firearms Control Act, 2000 (Act No. 60 of 2000), any person who has a valid claim to such firearm(s), or ammunition or such firearm part(s) may, within 21 days after the date of publication of this notice, make representations to me as to why such firearm(s), ammunition or firearms part(s) should not be destroyed. The representations must contain complete information of the firearm(s), ammunition or firearm part(s), the owner of the firearm(s), ammunition or firearm part(s) and the police station where the firearm(s) ammunition and firearm part(s) were surrendered to or forfeited to the State.
