**BOARD NOTICE 201 OF 2019****THE SOUTH AFRICAN PHARMACY COUNCIL****REGULATIONS RELATING TO CONTINUING PROFESSIONAL  
DEVELOPMENT (CPD)**

The South African Pharmacy Council hereby publishes in terms of Regulation 2(1)(a) of the *Regulations relating to continuing professional development* (CPD Regulations) published on 17 May 2019, GNR. 668, in terms of section 33(1)(o) of the Pharmacy Act, 53 of 1974, **the categories of persons** registered in terms of section 14 of the Pharmacy Act, **who are required to record their continuing professional development activities** as provided in the CPD Regulations.

**SCHEDULE**

- (a) Board Notice 174 of 2019, published on 27 September 2019 is hereby repealed;
- (b) All registered pharmacists shall be required to comply with requirements for Continuing Professional Development effective from 1 January 2020; and
- (c) All registered pharmacists shall submit a minimum of 6 (six) Continuing Professional Development activities by 31 December annually.

**THE RESTORATION REQUIREMENTS AND PROCESS FOR PHARMACISTS WHO HAVE BEEN REMOVED FROM THE REGISTER**

Section 23 of the Pharmacy Act, 53 of 1974, read with Regulations 21 and 22 of the *Regulations relating to the registration of persons and the maintenance of registers* (GNR.1160 published on 20 November 2000) provides for the restoration of pharmacists who have been removed from the register of pharmacists. The South African Pharmacy Council hereby publishes for comment the **Restoration requirements and process for pharmacists who have been removed from the register.**

**SCHEDULE**

1. Restoration requirements and process for pharmacists who have been removed from the register.

In this notice "the Act" shall mean the Pharmacy Act, 53 of 1974 (as amended), and any expression to which a meaning has been assigned in the Act shall bear such meaning.
