AMENDMENT TO BOARD NOTICE 200 OF 2019

Amendment to Board Notice published in the Government Gazette Board Notice No 42893 of 6 December 2019 with regards to the Fees and Charges for the calendar year 1 January 2020 to 31 December 2020 in terms of the Project and Construction Management Professions Act (Act No 48 of 2000).

Change of Wording Related to Fee

The South African Council for the Project and Construction Management Professions (SACPCMP) has developed, as part of its registration system upgrade, an enhanced search functionality including the ability to validate a Registered Persons' status. This functionality supports the Council's efforts to continually improve its service offering to stakeholders through the provision of a secure, user-friendly registration system facilitating improved governance for the organisation overall. The search-and-validation functionality will enable all Registered Persons to:

- 1. Include a validation token into a Registered Person's e-mail.
- Generate and download a status-certificate via the SACPCMP Registration self-serve portal for use (in PDF format) when submitting tender documentation or applying for a job.
- 3. Utilise a search-function to verify the status of a Registered Person.

The search-and-validation function is a live feed from the SACPCMP's registration platform. Due to the use of the search-and-validation functionality which is built directly into the SACPCMP's registration platform, the Council will no longer utilise PrivySeal in terms of the issuing of its registration certification.

SACPCMP invoicing will as such, no longer refer to a 'PrivySeal Fee'. This will be amended to: SACPCMP Certificate Fee. No increase in fees will be applicable as a result of the change of wording.
