CALL FOR NOMINATIONS FOR POSITIONS AS CHAIRPERSON OF NATIONAL LOTTERIES COMMISSION (NLC) AND AS NON-EXECUTIVE MEMBER OF THE NLC

The Lotteries Act, 1997 (Act No. 57 of 1997) (the Act), as amended, established the National Lotteries Commission (NLC) to monitor and enforce the implementation of the national lottery and the establishment of private lotteries and promotional competitions. The NLC is governed by a Board appointed in accordance with the provisions of this Act.

The Minister of Trade, Industry and Competition hereby invites nominations of persons to be appointed in two positions:

- As Non-Executive Member of the Board of the NLC; and
- As Non-Executive Chairperson of the Board of the NLC. (The anticipated appointment date is 1 December 2020).

Composition of the Board and Qualifications for Membership:

The Act provides for the Minister, subject to procedures set out, to appoint members of the board, which shall consist of inter alia: • A chairperson, who shall be a person with applicable knowledge or experience with regard to matters connected with the functions of the board; and • Members who have proven business acumen or applicable knowledge or experience with regard to matters connected with the functions of the board, and of whom at least one should be a legal practitioner admitted to practise in the Republic and at least one a chartered accountant in the Republic.

Only nominees not disqualified for membership of the NLC, nor conflicted and who comply with the confidentiality and restraint of trade clauses as outlined in the provisions of the Act (including section 3A, 3B and 3C), will be considered.

Copies of the relevant provisions of the Act is available on the dtic website.

Term of office: The Non-Executive Member or Non-Executive Chairperson of the NLC serves for a term not exceeding five (5) years.

Nomination Procedure: Nominations must be submitted in writing and must contain the following information: Detailed curriculum vitae that includes membership of all boards the nominee currently serves on or has served on in the past ten years, motivation for appointment and a certified copy of the identity document and certified copies of qualifications obtained.


In addition: • Background verification, including criminal record and citizenship checks, will form part of the selection process • It is the nominee's responsibility to have foreign qualifications verified by the South African Qualifications Authority (SAQA) • Preference will be given to candidates whose appointment will enhance representativity • A declaration made under oath or by affirmation to the Minister in terms of section 3A and 3B of the Act will be required, indicating that the nominee is not disqualified from appointment in terms of the Act.

The following forms which are obtainable from the dtic website or on request by email (Applications@thedtic.gov.za) must be fully completed and submitted: • A signed and completed nomination and acceptance form (Form 1 A) • A signed and completed form relating to the particulars of the nominee (Form B) • A written statement declaring any direct or indirect interest, financially or otherwise as referred to in section 3B of the Act and • Consent and indemnity form.
