Notice is hereby given in the National and Provincial Gazette that the Accounting Officer of the Provincial Department of Human Settlements intends to make allocations as per attached Schedule, in terms of Section (12) and (30) of the DORA Act, 2018, (Act No 1 of 2018); to Matlosana and Rustenburg local Municipalities. In terms of the Act any transfer to municipalities must be published in the government gazette.

The allocation referred to herein is a conditional grant to provide financial assistance to the existing Matlosana N12 and Bokamoso National Strategic Integrated Catalytic Human Settlements Projects. The expenditure therefore must be within these projects or as may be determined from time to time by the transferring Department and the receiving Municipalities.

The Department shall therefore give such technical and other general assistance as it may be able to provide in order to facilitate the effective implementation of the projects within a stipulated period of the transfer.
