NOTICE IN TERMS OF SECTION 13 (5) (C) (i) AND (ii) OF NATIONAL SPORT AND RECREATION ACT, 2007 (ACT NO. 18 OF 2007)

Background

1. On 4 November 2011, the former Minister of the Department of Sport and Recreation announced the appointment of a Committee of Inquiry to conduct an investigation into the affairs of Cricket SA, chaired by the retired Judge Christopher Robert Nicholson
2. The Committee completed its investigation and filed the report of the findings and recommendations on 7 March 2012 which was accepted by the Minister and Cricket SA respectively.
3. The committee recommended amongst others –
 - 3.1 **the amendment of the Constitution of Cricket SA so as to elect a smaller board with majority of independent, professionally skilled directors and non – executive directors;**
 - 3.2 member's association be restructured to give each affiliate two votes;
 - 3.3 the board be constituted, consisting of nine non – executive directors, to be voted for by the affiliates, with each director being required to enjoy two thirds support from total of affiliates...;
 - 3.4 ...;
 - 3.5;

4. Cricket SA has failed to comply with the Minister's directive in so far as the recommendations outlined in the Judge Nicholson Report of the Ministerial Committee of Inquiry in terms of the Act.

5. Now, invokes the provisions of section 13 (5) (c) (i) and (ii) and directs that –

5.1 the Department of Sport, Arts and Culture refrain from funding Cricket SA;

5.2 Cricket SA is henceforth derecognized as a National Federation.
