

NOTICE IN TERMS OF REGULATION 6 (2) AND (3) OF RECOGNITION OF SPORT AND RECREATION BODIES

- Cricket South Africa is hereby recognised as a national federation in terms of section 1 of the National Sport and Recreation Act, 1998 (Act No. 110 of 1998) as amended with immediate effect upon compliance with the recommendations of Judge Christopher Robert Nicholson Committee of Inquiry.
- Cricket South Africa must within 30 days upon publication of this Notice submit information to the Chief Director as outlined in subregulation (2) paragraph (a) and (b).
- Now, therefore, directs the Department of Sport, Arts and Culture to provide financial support for the development of cricket in the Republic upon submission of all relevant documents and/or information.
