

#### CALL FOR NOMINATION OF PERSONS TO SERVE ON THE SOUTH AFRICAN COUNCIL FOR PLANNERS

#### PLANNING PROFESSION ACT, 2002 (ACT NO. 36 OF 2002)

Under Section 4(3) of the Planning Profession Act, 2002 (Act No 360 of 2002), I, Mooketsa Ramasodi, (A)Director-General of the Department of Agriculture, Land Reform and Rural Development on behalf of the Minister, hereby invite interested persons, voluntary associations and organizations to submit nominations of suitably qualified persons who are prepared to serve as a member(s) of the South African Council for Planners in terms of the Planning Profession Act.

Categories of persons to constitute the Council are:

- Two planners in the full-time employ of the Department of Agriculture, Land Reform and Rural Development, in terms of Section 4(1) (a).
- One planner in the employ of provincial government nominated by the Provincial Government, in terms of Section 4(1) (b).
- Two planners in the employ of the municipal sphere of government (one from a municipality which is mainly rural in character and the other from municipality mainly urban in character) nominated by the municipality (ies) or an association representing planners at the municipal level or representing the interests of local government sphere of government, in terms of Section4(1)(c).
- Three planners from the planning education and training sector nominated by the Committee of University Principals, or Education and Training Institutions that offers training on the subject matter, in terms of Section 4(1)(d).
- Three persons to represent the interest of communities whom or may be affected by planning decisions nominated by interested persons, voluntary associations and organisations, in terms of Section 4(1)(e).

Three planners in private practice nominate by association(s) or institutions representing planners in private practice or representing the interest of planners in general, in terms of Section 4(1) (f).

Persons nominated must not be disqualified in terms of section 5 of the Planning Profession Act 2002. In appointing members of the Council, the Minister will have due regard to the planning profession principles contained in section 2 of the Act, the diversity of interests and the need to ensure and promote gender, disability and other demographic representativity.

Council members will hold office for a period of four years from the date the appointment takes effect which is to be published in the Gazette.

A nomination should be accompanied by an acceptance letter and curriculum vitae and should mention the category in which the person is nominated. The Director-General will take into account, among other things, the principles of transparency and representativity when appointing members of the Appeals Board.
