

### SECOND CALL FOR NOMINATION OF PERSONS TO SERVE AS MEMBERS OF THE APPEAL BOARD IN TERMS OF SECTION 24(3) OF THE PLANNING PROFESSION ACT, 2002 (NO. 36 OF 2002)

Under Section 24(6) of the Planning Profession Act, 2002 (Act No 36 of 2002), I, Mooketsa Ramasodi, (A) Director-General for the Department of Agriculture, Land Reform and Rural Development, acting on behalf of the Minister of Agriculture, Land Reform and Rural Development, hereby invite interested persons, voluntary associations and organizations to submit nominations of suitably qualified persons who are prepared to serve as member(s) of the Appeal Board in terms of the Planning Profession Act.

The Board will comprise of the following members:

- Three (3) persons who have been practising or teaching planning for a period of not less than 5 years, and
- Two (2) members of the public, at least one of whom is qualified in law and has at least five years of
  experience in the legal profession

The Appeal Board members will hold office for a period of four years from the date the appointment takes effect to be published in the *Gazette*.

A nomination should be accompanied by an **acceptance letter** and **curriculum vitae** and should mention the **category in which the person is nominated**.
