- I, Enoch Godongwana, Minister of Finance, acting in terms of the Division of Revenue Act, 2021 (Act No. 9 of 2021), hereby publish in the attached Schedules -
- (a) Conversion of a portion of the allocation in respect of the National Health Insurance Indirect Grant under the Act; and
- (b) The addition of the converted allocation to Human Resources and Training Grant to provinces .

For ease of reference only and where applicable, the attached Schedules reflect the allocations published in the Division of Revenue Act, 2021 (Act No. 9 of 2021) Schedule 6, Part A and Schedule 5 Part A.

Explanatory Memorandum to National and Provincial Allocations set out in the Schedules

This *Gazette* is published in terms of the Division of Revenue Act, 2021 (Act No. 9 of 2021), as amended, and provides information on adjustments to existing allocations to the national department of Health and provinces in the 2021/22 financial year.

This is necessitated by the need to convert funds in terms of Section 20 of the Division of Revenue Act, 2021, as amended, and the need to re-allocate the converted funds to seven provinces, as approved in terms of Section 20 of the Division of Revenue Act, 2021.

This *Gazette* therefore updates information that was published in the Division of Revenue Act, 2021.

This notice affects the National Health Insurance Indirect Grant and the Human Resources and Training Grant:

- a) In compliance with Section 20 of the Division of Revenue Act, 2021, as amended, the national Department of Health converts R143.09 million from the National Health Insurance Indirect Grant to the Human Resources and Training Grant.
- b) In compliance with Section 20 of the Division of Revenue Act, 2021, as amended, the national Department of Health allocates funds to Eastern Cape (R25.3 million), Free State (R13.9 million), Gauteng (R70.8 million), KwaZulu-Natal (R5.9 million) Limpopo (R10.3 million), Mpumalanga (R8.4 million) and North West (R8.4 million), following revised allocations by the national department of Health.
