NOTICE 508 OF 2021

INTERNATIONAL TRADE ADMINISTRATION COMMISSION OF SOUTH AFRICA

CORRECTION NOTICE

The following paragraphs replace the corresponding paragraphs in Notice No. 499 of 2021, which appeared in Government Gazette No. 45043 of 24 August 2021:

INCREASE IN THE RATE OF DUTY ON:

- 1. "Other paper and paperboard, not containing fibres obtained by a mechanical or chemimechanical process or of which not more than 10 per cent by mass of the total fibre content consists of such fibres, of a mass of 55 g/m² or more but not more than 90 g/m², of a width exceeding 150 mm in the unfolded state, classifiable in tariff subheading 4802.55.20 from free of duty to 20 per cent *ad valorem* by the creation of a new 8-digit tariff subheading for the said goods";
- 2. "Other paper and paperboard, not containing fibres obtained by a mechanical or chemimechanical process or of which not more than 10 per cent by mass of the total fibre content consists of such fibres, of a mass of 40 g/m² or more but not more than 150 g/m², in sheets with one side not exceeding 435 mm and the other side not exceeding 297 mm in the unfolded state, other, classifiable in tariff subheading 4802.56.90 from 10 per cent *ad valorem* to 20 per cent *ad valorem*";
- 3. "Other paper and paperboard, not containing fibres obtained by a mechanical or chemimechanical process or of which not more than 10 per cent by mass of the total fibre content consists of such fibres, other, of a mass of 55 g/m² or more but not more than 90 g/m², in strips of a width exceeding 150mm in the unfolded state, classifiable in tariff subheading 4802.57.20, from free of duty to 20 per cent *ad valorem* by the creation of a new 8-digit tariff subheading for the said goods".
