RE-ADVERTISEMENT – CALL FOR NOMINATION OF CANDIDATES TO SERVE AS BOARD MEMBERS OF THE CONSTRUCTION INDUSTRY DEVELOPMENT BOARD

The Honourable Minister of Public Works and Infrastructure, Ms Patricia de Lille, MP, hereby invites nominations for new members to serve on the Board of the Construction Industry Development Board (CIDB). The CIDB is a statutory body established in terms of Section 2 of the Construction Industry Development Board Act, No. 38 of 2000 ("the CIDB Act"), to provide strategic leadership to construction industry stakeholders, stimulate sustainable growth of the industry, promote good performance and devise interventions for enhanced service delivery and transformation of the construction industry within an enabling and regulated environment.

ELIGIBILITY CRITERIA

Given the transformative role that the CIDB plays within the construction sector, it is essential that its Board members have demonstrated strong leadership qualities and that they are committed to the development and enhanced performance of the construction industry, within the context of the 7 key national priorities of the 6th Administration.

Board members must possess knowledge and/or expertise in the following areas: construction industry or related built environment professions; construction procurement; B-BBEE legislation and the emerging sector; training, research and development; building and construction law; labour relations policy and legislation; communication, marketing and public relations; project management; health and safety; financing, especially in relation to infrastructure development; accounting, compliance and reporting; audit and risk management, including combating fraud and corruption. Due consideration will be given to race, gender, disability and geographic location in the composition of the Board.

DISQUALIFICATION CRITERIA

The following persons are not eligible to serve on the CIDB Board, as determined in section 6(8) of the CIDB Act. A person that:

- Is not a South African citizen and not ordinarily resident in the Republic;
- Is an un-rehabilitated insolvent, whose insolvency was caused by his or her negligence or incompetence;
- Is or was a consultant to the CIDB in the past three financial years; is a supplier or customer; has a contractual relationship with the CIDB; or is a professional advisor to the CIDB;
- Was convicted in South Africa, of an offence other than an offence committed prior to 27 April 1994 associated with political objectives, and was sentenced to imprisonment without the option of a fine or, in the case of fraud or corruption, to a fine or imprisonment or both;
- Was convicted in a foreign country, of an offence, which is also an offence in South Africa, and was sentenced to imprisonment without an option of a fine or, in the case of fraud or corruption, to a fine or imprisonment or both; or
- Has been declared by a court to be mentally ill or unfit.
- A political office bearer must vacate his/her position as soon as they are appointed as a Board member.

TERM OF OFFICE

The term of office of Board members is three years effective from the date of appointment. Individual Board members may be reappointed to the Board for one consecutive term. Candidates will be subjected to a security screening process.

REQUIRED INFORMATION

Nominations must be complete, in writing and must include the following:

Nomination Form: The application must be completed on a Nomination Form, which is available on the DPWI website: www.publicworks.gov.za on the Notices tab: **Call for Nominations**. The application should include a **Curriculum Vitae (CV)**: (not more than two pages), covering at least the following: full name, ID number, residential address; race, gender, contact email address, telephone numbers, qualifications, experience and employment; current and former board memberships and the names and contact details of at least two referees.
Declaration Form: as detailed below, completed and signed.

Motivating Memorandum: (one page only) motivating why the nominee is eligible, by demonstrating how they would drive the developmental agenda of South Africa using the Objects of the CIDB Act and facilitate the transformation of the construction industry, within their area of expertise. **SA ID Document:** Provide a certified copy of the nominee's South African ID document. **Qualifications:** certified copies of the nominee's qualifications
