

- e. provide technical guidance to the Department on the implementation of infrastructure projects;
- f. propose innovative solutions to infrastructure challenges in the PSET system
- g. develop mechanisms addressing expenditure backlogs in infrastructure projects in the PSET system
- h. serve as a leverage for stakeholder engagement within the PSET system
- i. guide the PSET system in ensuring that its achieves its purpose of utilising infrastructure as a lever for:
  - o teaching and learning in institutions;
  - o an enabler for economic growth; and
  - o a driver for transformation in the PSET system.
