**AMENDMENTS TO THE TERMS OF REFERENCE OF THE COMMISSION OF  
INQUIRY INTO ALLEGATIONS OF STATE CAPTURE, CORRUPTION AND FRAUD  
IN THE PUBLIC SECTOR INCLUDING ORGANS OF STATE**

### Definition

1. In this Proclamation "Terms of Reference" means the terms of reference published under Proclamation No. 3 of 2018 in published in the Government Gazette No. 41403 of 2 January 2018 as amended by Proclamations No. 34 of 2018, No. 18 of 2020, No. 12 of 2021 and No. 31 of 2021.

### Amendment of the Terms of Reference

2. The Terms of Reference is hereby amended by the substitution of paragraph five (5) of the following paragraph"

"5. The Commission shall submit its report and recommendations to the President within **[180 days]** within a period three month calculated from 1 October 2021."
