**NATIONAL ENVIRONMENTAL MANAGEMENT ACT, 1998
(ACT NO. 107 OF 1998)****CONSULTATION ON THE AMENDMENT OF THE IDENTIFICATION IN TERMS OF SECTION 24(5)(a) AND (b) OF THE NATIONAL ENVIRONMENTAL MANAGEMENT ACT, 1998, OF THE PROCEDURE TO BE FOLLOWED IN APPLYING FOR ENVIRONMENTAL AUTHORISATION FOR LARGE SCALE ELECTRICITY TRANSMISSION AND DISTRIBUTION DEVELOPMENT ACTIVITIES IDENTIFIED IN TERMS OF SECTION 24(2)(a) OF THE NATIONAL ENVIRONMENTAL MANAGEMENT ACT, 1998 WHEN OCCURRING IN GEOGRAPHICAL AREAS OF STRATEGIC IMPORTANCE**

I, Barbara Dallas Creecy, Minister of Forestry, Fisheries and the Environment hereby, in terms of section 24(5)(a) and (b) of the National Environmental Management Act, 1998 (Act No. 107 of 1998) and regulation 15(2) of the Environmental Impact Assessment Regulations, 2014, as amended, give notice of the intention to amend the procedures published under Government Notice No. 113 of Government Gazette No. 41445 of 16 February 2018, as set out in the Schedule hereto.

The amendment is necessary as the intention of paragraph 5 of Government Notice No. 113 of Government Gazette No. 41445 of 16 February 2018 was to require a route which has been pre-negotiated with landowners to be submitted as part of the application for environmental authorisation. However, paragraph 5 referred to the activities identified in paragraph 3 of the same Notice, which included only activity 9 of Environmental Impact Assessment Regulations Listing Notice 2 of 2014, as amended, which was the correct activity for the streamlining of the assessment process, but not correct in relation to the objectives of paragraph 5. This amendment therefore corrects the omission of activity 11 of Environmental Impact Assessment Regulations Listing Notice 1 of 2014, as amended, and any other listed and specified activities necessary for the realisation of such facilities, from the requirement to submit a route pre-negotiated with landowners as part of the environmental authorisation application.

SCHEDULE**Substitution of paragraph 5 of Government Notice No. 113 published in Government Gazette No. 41445 of 16 February 2018**

1. The following paragraph is hereby substituted for paragraph 5:

- "5. For applications for environmental authorisation for large scale electricity transmission and distribution facilities, where such facilities trigger—
- activity 11 of the Environmental Impact Assessment Regulations Listing Notice 1 of 2014, as amended, and any other listed or specified activities necessary for the realisation of such facilities; or
 - activity 9 of the Environmental Impact Assessment Regulations Listing Notice 2 of 2014, as amended, and any other listed or specified activities necessary for the realisation of such facilities;

routes that have been pre-negotiated with landowners must be submitted as part of such applications for environmental authorisation."

Transitional arrangements

2. An application for environmental authorisation which is pending when these amendments take effect must be dispensed with as if these amendments have not yet taken effect.
