

SOUTH AFRICAN SCHOOLS ACT, 1996 (ACT NO 84 of 1996)

NATIONAL NORMS AND STANDARDS FOR SCHOOL FUNDING (NNSSF)

- 1. I, Angelina Matsie Motshekga, Minister of Basic Education, hereby, in accordance with section 39(10) of the South African Schools Act, 1996 (Act No. 84 of 1996), publish the list per province, of schools that may not charge school fees.
- The Members of the Executive Council (MECs) responsible for education in provinces have identified the specific schools in the province that may not charge school fees [that will be no-fee schools as contemplated in section 39(9) of the South African Schools Act, 1996] in 2022.
