HIGHER EDUCATION ACT, 1997 (ACT NO. 101 OF 1997)

CALL FOR NOMINATIONS OF MEMBERS FOR THE COUNCIL ON HIGHER EDUCATION

The Council on Higher Education is an independent statutory body established in May 1998 as provided for by Section 4 of the Higher Education Act (Act No. 101 of 1997, as amended), and it also functions as the Quality Council for Higher Education in terms of the National Qualifications Framework Act (Act No 67 of 2008, as amended). It is a Schedule 3A national public entity in terms of the Public Finance Management Act (Act No. 1 of 1999). The ordinary members of the Council on Higher Education must be appointed by the Minister on the basis of the following criteria - balance of stakeholder interests and expertise; racial and gender representivity; deep knowledge and understanding of higher education; understanding of the role of higher education in reconstruction and development; and known and attested commitment to the interests of higher education. The term of office of the Chairperson of the CHE comes to an end on 14 July 2022. The term of office of thirteen (13) ordinary members comes to an end on 14 December 2022.

- I, Bonginkosi Emmanuel Nzimande, MP, Minister of Higher Education, Science and Innovation, in accordance with the Higher Education Act, 1997 (Act No. 101 of 1991) hereby request-
 - (a) the public;
 - (b) national organisations representing students, academic employees;
 - (c) employees other than academic employees;
 - (d) university principals;
 - (e) technikon principals;
 - (f) principals of higher education colleges;
 - (g) principals of private higher education institutions;
 - (h) organised business;
 - (i) organised labour; and
 - (j) research and science councils.

to submit to me, within 21 working days from the date of publication of this Notice, the names of persons who by virtue of their knowledge and experience, may be considered for appointment as members of the aforesaid Council. A nomination and declaration of interest form can be obtained at www.dhet.gov.za.
