GENERAL NOTICE IN TERMS OF THE RESTITUTION OF LAND RIGHTS ACT, 1994 (ACT NO. 22 OF 1994), AS AMENDED

Notice is hereby given in terms of section 11(1) of the Restitution of Land Rights Act, Act No. 22 of 1994 as amended, that a claim for restitution of land rights has been lodged on portions of the farm located within Vhembe and Mopani District in the Limpopo Province.

Mr. Munyadziwa Alpheus Netshimbupfe lodged the land claim on behalf of Tshimbupfe community before the cut-date of 31st of December 1998.
